
# REQUEST FOR QUALIFICATION (RFQ) DOCUMENT

## Bus Rapid Transit System for "Bus Operation Plan and ITS for Orange, Green and Red Line" Under Public Private Partnership Mode

#### REQUEST FOR QUALIFICATIONS

- 1.1. Transport and Mass Transit Department, Government of Sindh (TMTD, GoS) invites proposals from the reputable and experienced Consulting Firms to prepare a Feasibility Study for Bus operation plan and Intelligent Transport System (ITS)/Fare Collection Mechanism along with Transaction advisory services for the following 3 BRTS Lines under PPP mode of financing:
  - BRTS Green Line: Surjani Town to Municipal Park M.A. Jinnah Road (21.2 Km)
  - 3RTS Orange Line: TMA Office Orangi Town to Board Office Chowrangi (4.7 km)
  - 3RTS Red Line: Modal Colony to Tower via University Road (22.2 km)
    In this regard TMTD, GoS wants to prequalify potential consulting firms for issuing Request for Proposal (RFP) document
    Interested consulting firms would need to furnish relevant documents to demonstrate experience and expertise to undertake the above project.
- 1.2. The requisite information and evaluation criteria for short-listing Consulting Firm(s)/Consortia is attached herewith. Only shortlisted Consulting Firm(s)/ Consortia would be issued Request for Proposals (RFP) for submission of Technical and Financial Proposals.
- 1.3. Firms / consortia desirous of being shortlisted for issuance of RFP, are requested to fill forms (4 in number) attached herewith.
- 1.4. The filled-in forms duly signed along with Pre-Qualification Documents, clearly marked on a sealed envelope (3 sets + soft copy in a CD in PDF format), should reach the office not later than 02:00 p.m. on Monday, August 31<sup>st</sup>, 2015.

#### 2. OBJECTIVES

- 2.1. Keeping in view the ever increasing population of Karachi and the expansion of the urbanized area, the Transport and Mass Transit Department, Government of Sindh has envisaged an increase in traffic demand in the city. In this regard, a study by the name of "The Karachi Urban Transport Master Plan 2030" (KUTMP) was conducted by Japan International Cooperation Agency (JICA) in close coordination and facilitation of Mass Transit Cell. The study suggests 2 Mass Rapid Transit (MRT) and 6 BRTS lines besides Revitalization of Karachi Circular Railway (KCR). The feasibility and transaction structure of BRTS would enable the Transport and Mass Transit Department, Government of Sindh to make an informed decision which shall ensure an affordable, sustainable and replicable system.
- 2.2. This Pre-Qualification Documents would enable TMTD, GoS to pre -qualify the best qualified and appropriately experienced Consulting Firm(s)/Consortia for Feasibility Study and Transaction Advisory Services.

#### 3. SCOPE OF WORK

#### 3.1 BRT Operations Plan

- **3.1.1** Review and suggest changes / amendments in existing laws & rules of business related to transport.
- 3.1.2 Performing field surveys needed for developing BRT operations plan
- 3.1.3 Develop travel demand forecast models needed for operational plan.
- **3.1.4** Assess efficiency of already designed BRT infrastructure with respect to BRT Operations plan sufficiency.
- 3.1.5 Prepare BRT fleet procurement plan
- 3.1.6 Prepare bus specifications and Acceptance Test Parameter (ATPs)
- 3.1.7 Prepare detailed design for BRT Operational Plan
- 3.1.8 Develop fare policy
- **3.1.9** Develop financial model for bus operations & unified criteria for operational subsidy to operators with sustainability.
- **3.1.10** Prepare business model for BRT operations for minimizing operational subsidy to make the project sustainable.



- 3.1.11 Develop business & marketing plans to address maximization of revenues.
- **3.1.12** Develop concession agreements / Service Level Agreements (SLAs) for bus operations.

## 3.2 Intelligent Transportation Systems (ITS)

- **3.2.1** Develop user requirements, procedures, protocols, rules and mechanisms for an integrated ITS system considering mass transit system in Karachi.
- **3.2.2** Identifying key areas where governmental controls are essential and ensuring full authority and control of regulatory authority / SMTA.
- 3.2.3 Develop technical standards, specifications and RFPs related to various ITS system components such as fare collection, Fleet Monitoring & Management, Transit Signal Priority, Passenger Information Systems, Precision Docking System, Security & Surveillance, Data Centre, Command & Control Centre, Secured Communication System etc.
- **3.2.4** Developing concession agreements / Service Level Agreements (SLAs) for ITS providers and ITS Operators.
- 3.3. The Transaction Advisor is therefore expected to have to have the technical, economic, legal, environmental, and financial; and project management expertise in its team / consortium.



#### 4. IMPORTANT NOTE

- 4.1. Any document/ statement provided if proved false, misstated, concocted, or incorrect at any time during or after pre-qualification will result into permanent disqualification and black listing of the firm/ Company/ Partners/ Joint Venture with their names displayed on SPPRA website.
- 4.2. The Consulting Firm(s) /Consortia would be selected through a transparent process as per Sindh Public Procurement Rules (SPPR) rules 2010. Request for Proposal (RFP) would only be issued to pre-qualified firm(s) /consortia.
- 4.3 TMTD, GoS has the right to modify the scope of consultancy services at RFP stage with particular reference to inclusion or exclusion of Intelligent Transport System (ITS) at its discretion.
