SUBJECT: RFP ADDENDUM SUBMISSION.


In furtherance of our letter bearing reference No. EDU/E&A/DS(GA)EDU/E&A/PPP/SEMO/EOI/14/17 dated 28.10.2015, it is reiterated that the EOI for shortlisting of the EDUCATION MANAGEMENT ORGANIZATIONS (EMOs) was published in local newspapers dated 13<sup>th</sup> of May 2015. The same was also hoisted on the websites of the procuring agency (i.e. Education & Literacy Department, Government of Sindh (ELD-GoS)), PPP Unit of the Finance Department and on SPPRA's website.

In response to the EOI published, thirty nine (39) pre-qualification applications were received by the ELD-GoS on the bid submission deadline i.e. 10<sup>th</sup> June 2015. The pre-qualification applications were opened on the same day by the Technical and Financial Evaluation Committee (TFEC) constituted for this Project. Thereafter, 20 applications were shortlisted as by the TFEC in accordance with the criteria set down in the short listing document. Furthermore, RFP was launched in accordance with the SPPRA Rules. Letter numbers EDU/E&A/DS(GA)EDU/E&A/PPP/SEMO/EOI/14/16 and EDU/E&A/DS(GA)EDU/E&A/PPP/SEMO/EOI/14/17 may be reiterated for the sake of brevity.

That a pre-bid meeting was conducted with all the pre-qualified bidders. It was pointed out by the prequalified bidders, that the bid submission date may be extended in order to provide a comprehensive response/proposal to the RFP, along with minor changes in the RFP document. As such, an Addendum (**Annexure A**) to the RFP was prepared and approved by the TFEC on 30 November 2015 (Minutes of the TFEC – **Annexure B**), to be sent to all the pre-qualified bidders via email in furtherance of the bidding process under SPPRA Rules, 2010.

Lastly, reference to your letter No. Mgn (Assessment-I)REF-520/SPPRA/37-1(EDU/E&A)/15-16/8396 dated 02.11.2015, it may be noted that the procuring agency furnished a detailed Pre-Qualification Assessment report, attached again for your reference (**Annexure C**), after shortlisting the firms in accordance with the shortlisting criteria set down in the short listing document (already furnished for your record).
