- Date & time of submission of tenders: The interested bidders shall submit their bids on the prescribed form, available on written request on the firm/company letter pad available from the office of the Assistant Director (Admin & Accounts)/DDO, Directorate of Oil & Gas, Energy Department along with a Pay Order / Bank Draft amounting to Rs.1000/- (Non-refundable) in favor of the Assistant Director (Admin & Accounts) / DDO, Directorate of Oil & Gas, Energy Department on any working day upto 02:00 PM, on or before 27-11-2015 which will be opened publicly on 27-11-2015 at 3:00 pm in the presence of bidders or their representatives, who may care to be present.
