- 01. The Tender / Quotation will not be considered unless it is submitted on the prescribed forms issued to interested Tenderers / Quotationers,
- 02. Tenders / Quotations will be opened in the presence of such Contractor / Suppliers who may like to be present on the opening date.
- 03. All Drugs / Medicines & other items including all tests etc shall be subjected to being passed by the Convener Health Welfare Committee / Medical Superintendent, Abbasi Shaheed Hospital or Coordination Health Welfare Committee.
- 04. All spirituous preparation should be B.P standard and be quoted as duly free rates.
- 05. The Convener Health Welfare Committee / Medical Superintendent reserve the right to reject the whole or part of the tender without assigning any reason thereof.
- 06. Contract will be cancelled if the Tenderers whose tender is accepted fail to supply the Drugs / Medicines / Surgical items / Orthopedic implants / Intra ocular Lenses (FDA approved) / Lab tests / Biopsy reports / C.T scan / MRI /VP Shunt / PTFT Graft/ Whole Blood / other products of Blood etc, according to the sample submitted within the prescribed time.
- 07. If any Contractor / Suppliers could not delivered the above mentioned facilities to deserving patients within the stipulated period, the Drugs / Medicines & other items will be purchase at the risk and cost of the Contractor / Suppliers and security deposit of the suppliers will be forfeited.
