It is informed that Tender for procurement of Computer & I.T. Equipment and Furniture & Fixtures were invited through tender notice published in leading newspaper on 24.01.2016 and hoisted on SPPRA Website on 14.01.2016 at Sr. No. 26173 and Technical Proposal were opened on 09.02.2016 and Financial Proposal were also opened on 05.04.2016 after completing codal formalities Comparative Statement along with Bid Evaluation Report were prepared and sent to SPPRA vide this office letter dated 24.05.2016 (Copy enclosed) but during this exercise Bid validity period were going to be expired on 17.04.2016 for this purpose extension for 90 days were obtained from the Competent Authority (Copy enclosed) and also the same were intimated to your good office vide this office letter dated 16.05.2016 (Copy enclosed) but after reasonable time the Authority has still not hoisted of BER on SPPRA Website and during this period the validity of bid has again expired on 16.07.2016 and it is not possible to award the contract and finalize the tender meanwhile a letter referred to above have been received towards information that the procuring agencies did not furnished Technical Evaluation Report, whereas and Bid Evaluation Report was received after expiry of bid validity period, extension of bid validity period is required.

It is also informed that due to Bid validity period was again expired for this purpose approval of cancellation of the bid has been taken by the Competent Authority and therefore, the bid may be treated as cancelled the concerned firm<sup>all</sup> is being also intimated accordingly.

Laboratories at 60 Institutes of STEVTA vide tender notice published in Daily Dawn, Daily Jang & Daily Kawish on 24.01.2016 and on the website of SPPRA on 14.01.2016 at Sr.No.26173(copies at Flag-A). The bids were invited on the basis of single stage – two envelopes procedure; comprising Technical & Financial Proposals.

The Technical Proposals were opened by the Procurement Committee on 9<sup>th</sup> February 2016 in presence of Bidders & their representatives. But, due to some administrative issues, the contract of award could not be finalized within stipulated period of bid validity.

In this respect, it is submitted that according to Rule-38 of SPP Rules 2010, the normal bid validity period is of 90 days in case of National Competitive Bidding, which can be extended for further period of 90 days, if required. The Bids in question were opened on 09.02.2016, hence, the bid validity is going to be expired on 08.05.2016. Further, according to SPPRA Rule-49, the contract could be awarded to a successful bidder within original or extended period of Bid validity.



It is informed that Tender for Procurement for Computer/I.T. Equipment and Furniture for setting up I.T. Labs at 60 Institutions of STEVTA were invited and the Tender Notice were hoisted on SPPRA Website on 14.01.2016 at Sr. No. 26173 (Copy enclosed) and the Tender Notice were also published in the leading Newspapers Daily Dawn, Daily Jang & Daily Kawish on 24.01.2016 (Copy enclosed), the Bids were invited on the basis of Single Stage Two Envelope procedure comprising Technical & Financial Proposal, the Technical Proposal were opened by the Procurement Committee on 09.02.2016, as the Four interested firms were participated in the bid for Package-I after Evaluation of Technical Proposal the following firm has been qualified in the Technical Proposal.

1. M/s. Micro Innovation & Technology, Karachi.
2. M/s. Faiz Scientific Company, Karachi.
3. M/s. Kontinental Establishment Pvt. Ltd. Karachi.

As such the Financial Proposal were opened on 05.04.2016 and three firm M/s. Micro Innovation & Technology, Karachi, M/s. Faiz Scientific Company, Karachi and M/s. Kontinental Establishment Pvt. Ltd. Karachi has quoted their rates in Package-I, the sample of Desktop Computer i3 & i5 were required to check the specification according to the Tender requirement so that Package-I could be finalized the above mentioned firm were provided the

sample and the Procurement Committee also required the Computer Brand Registration Certificate to ensure the 1<sup>st</sup> Criteria i.e. Branded. 107

In the mean time according to Rule-38 SPPRA Rules, 2010 the normal bid validity period is of 90 days in case of National Competitive Bidding but due to transparency manner the Contract of Award could not be finalize within stipulated period of bid validity, after getting approval by the Competent Authority for extension of 90 days validity period.

The above mentioned Tender for purchase of Computer there are two brand quoted which are Dell and HP by the two different firm and M/s. Faiz Scientific Company, Karachi has provided One Apple.

It is submitted that this office were requested to the qualifying firm to provide the sample to check and verify the specification along with Computer Brand Registration Certificate vide this office letter No. STEVTA/P/I.T. Lab/1(56)/2015/160 dated 07.04.2016 (Copy enclosed) in response to this letter the firm M/s. Micro Innovation Technology, Karachi and M/s. Kontinental Establishment Pvt. Ltd. Karachi were provided sample along with Registration Certificate, after few days M/s. Faiz Scientific Company, Karachi has provided sample along with Registration Certificate issued from Intellectual Property Organization Trade Mark Registry vide his letter No. FSC-TIND-160416/2068 dated 16.04.2016 (Copy enclosed). In response of this office letter No. STEVTA/P/I.T. Lab/1(56)/2015/171 dated 14.04.2016 (Copy enclosed).

In view of the above position SPPRA is requested to kindly give the suggestion and guideline regarding Branded of Computer according to SPPRA Rules.

The Technical Proposal were opened on 09.02.2016 at 11:30 a.m. and Financial Proposal were also opened on 05.04.2016 (Flag-A) after completing codal formalities the Minutes of Meeting Technical Proposal and Financial Proposal were also been prepared after then the comparative statement along with Bid Evaluation Report were also been prepared and were sent to SPPRA vide this office letter dated 24.05.2016 (Flag-B) but during this exercise Bid validity period were going to be expired on 17.04.2016 for this purpose further 90 days extension were obtained and intimated to SPPRA vide this letter dated 16.05.2016 (Flag-C) but after stipulated time SPPRA has still not yet been hoisted BER on their Website and during this period the validity of bid has again expired and there is no possible to award the contract to the lowest bidders.
