- As a consequence of this meeting, following amendments have been made in the Tender Specifications:-
- In the heading at Serial No. 1 "Positioning Arm", in 1.7 "Rotation speed: 50/second or more in LAO/RAO" should be read as "Rotation speed: 40/second or more in LAO / RAO".
- In the heading at Serial No. 2 "Digital Flat Panel Detector 12x16 inch", in 2.3 "12x16 inches large field of view" should be read as "30x40cm large field of view Rectangular Panel is required".

In the heading of Serial No. 5 "X-Ray Generator", in 5.6 "Should have capability of doing digital pulsed fluoroscopy at 10/2.5/15 frames and 25/30 frames per second" should be read as "Should have capability of doing digital pulsed fluoroscopy at 10/2.5/15 frames and 25/30 frames per second or similar".
- 4. In the heading of Serial No. 6 "Digital Imaging & Acquisition / Fluoroscopy", in 6.5 "Magnetic Disk Capacity for storage of 100,000 images in 1024x1024 on the magnetic disk of main console" should be read as "Digital Imaging & Acquisition / Fluoroscopy", in 6.5 "Magnetic Disk Capacity for storage of 64,000 images or greater in 1024x1024 on the magnetic disk of main console".
- 5. In the heading of Serial No. 6 "Digital Imaging & Acquisition / Fluoroscopy", in 6.9 "Rotational DSA package with 50 degrees /second minimum" should be read as "Rotational DSA package with 40 degrees/second or more".
- 6. In the heading of Serial No. 7 "Monitoring System", in 7.3 "Two monitors for live images and road mapping in the control room 18inch or larger LCD/LED and 2 in Cath Room" should be read as "Two Medical Grade Monitors for live images and road mapping in the control room 18inch or larger LCD/LED and 2 in Cath Room".
- 7. In the heading of Serial No. 9 "Software / Hardware Packages", in 9.14 "Table should have stepping top for peripheral DSA for 5 or more steps programming" should be read as "Table should have stepping top for peripheral DSA / Bolus Chase for 5 or more steps programming".
- 8. In the heading of Serial No. 12 "Accessories of Angiography System", in 12.1 "Physiological Hemodynamic Monitoring System (from same manufacturer of angio system or its joint venture partner) Multichannel for 2 channels IBP, Cardiac output with thermo dilution method. 12 lead ECG and SPO2" should be read as "Physiological Hemodynamic Monitoring System (from same manufacture of angio system or its joint venture partner) integration should be FDA/CE/MHLW approved. Multichannel for 16 channels IBP, Cardiac Output with thermo dilution method. 12 Lead ECG and SPO2".

 In the heading of Serial No. 14 "Quality & Safety Standards / Radiation Protection", in 14.1 the word "manufacturing" should be read as "Manufacturer".

10. At page 25, 26 & 27, the word "Country of Origin" should be read as "Country of Manufacturer".
