**Minutes of Meeting of Complaint Redressal Committee for Pre-qualification of Contractors held on 23 November 2016**


- 1) A Meeting of Complaint Redressal Committee for reviewing the complaint launched by M/S Kashif Constructors was held on 23 November 2016 in the conference room of office of the General Officer Commanding 16 Division Pano Aqil Cantt. Following attended the meeting:-

**Item No 1: Review of the complaint launched by M/S Kashif Constructors.**


- 2) Para wise review of the complaint launched by M/S Kashif Constructors was made by the committee. After having gone through the written response of Project Director Cadet College Khairpur on the complaint of M/S Kashif Constructors and detailed analysis of the Company profile provided by M/S Kashif Constructors, Complaint Redressal Committee is of the opinion that process of Pre-qualification of contractors has been fair and transparent.
- 3) As per serial No 4-a and b of the TOR (selection criteria ) Companies/ firms were asked to provide list of similar projects completed in last 5 years (2011-2015) with completion cost & client certificates and list of similar projects currently in progress. Total marks allocated for each category were 15 (total-30). After analyzing the list of projects undertaken during last five years and list of projects in progress, the Complaint Redressal Committee concluded that the firm does not have any worthwhile expertise in construction of buildings/external development. The firm has only carried out rehabilitation/renovation of some schools. The award of less mark in this category by the Procurement Committee is justified.
- 4) As per Para 5-b of the selection criteria, companies / firms were asked to provide detail of key technical staff, their qualification and experience who would be deputed for this project along with CVs duly signed by the person. Having analyzed the list of persons who would be deputed for the project, the Complaint Redressal Committee concluded that the firm does not have required persons who

can handle the large and complex work of Cadet College Khairpur. The persons deputed are just Diploma holders and with Matric/SSC qualification. For example the Firm has deputed Sikander Ali Narejo for proposed position of Sub Engineer (Mechanical Works), but his qualification is DAE Electrical. The less marks awarded by the Procurement Committee is again justified.

- 5) **Decision by the Complaint Redressal Committee.** The Complaint Redressal Committee unanimously decides that process of the Pre-qualification of contractors undertaken by the Procurement Committee of Cadet College Khairpur is fair and transparent. Complaint of M/S Kashif Constructors does not have any solid grounds/justifications and upholds the decision taken by the Procurement Committee Cadet College Khairpur.
