1. "Portion C. HVAC Equipment (page 20- 21)" is deleted from said tender and a fresh tender will be issued with inclusion of "Consumables" and "List of replaceable Items". Point no.2 of page no. 20 would also be waived off.
2. Item no. c (ME-01 Heating, Ventilation, Air-conditioning) from Mandatory Requirements of Evaluation criteria at page no. 12 is deleted. While last point in same category i.e. "A certificate of Financial Soundness of the firm from Bank stating that it can conduct business upto 25.00 million each year" is replace with a figure of 10. Million.


