

The bid received from M/s Print Ideas found eligible quoting total of Rs.4,209,000/- as he is fulfilling all the criteria of eligibility therefore the award of contract is due for him. The lowest bidder M/s United Graphics' bid is not acceptable as his bid is not fulfilling the eligible criteria.

It is noted that the bid of M/s print Ideas much higher to our estimated cost reported in procurement plan for the year 2017, i.e one million for publicity & advertisement and two million for Printed Stationery.

Further, inadvertently the bid was called for stationery items relating to SIL and publicity items required for "Personal Accident Insurance Scheme" like billboards, banners, standees etc. we understand that from the control point of view and for payment procedure, separate tender for both the items is called.

Therefore, we suggest that the above mentioned tender may be cancelled and issue fresh tenders & NITs separately.
