The meeting was convened evaluate the technical proposals submitted by the shortlisted firms to hire consultant for the Project under Public Private Partnership ("PPP") mode. Agenda # 1: Approval of the evaluation of Technical Proposals

2. The chair welcomed the CSC members. The forum was appraised regarding the background of the project and findings of the evaluation of the technical bids received under the Request for Proposal. The technical proposals evaluation was discussed in detail pursuant to eligibility and evaluation criteria of bidding documents (RFP). The detailed technical proposals evaluation is attached as [Annexure-B]. After thorough evaluation by the members of CSC, it was found that all of three bids received were technically disqualified and found non-responsive (by securing less than 80 marks) and no required documentation for the relevant experience of the Consortium as per RFP Section 2.18.7 were not provided by the bidders. The technical score as given below:




