COMPLAINT REDRESSAL COMMITTEE REPORT REGARDING COMPLAIN OF M/S. GRESHAM'S EASTERN (Pvt.) Ltd. IN RESPECT OF SHORTLISTING OF FIRMS/JV

In compliance of SPPRA Letter No. A.D(Assest)/SPPRA/31629/2017/9088 dated 9th February 2018, on the above cited matter. A Complaint Redressal Committee In accordance with the Rules 31 (1) & (2) of SPPRA Rules 2010, the committee was constituted with the approval of Competent Authority comprising of following members:

- 1. Mr. Saleem Ahmed, DMD (Planning) KW&SB
- 2. Syed Iftikhar-ul-Hassan, District Account Officer, AG Sindh
- 3. Dr. M. Bashir Lakhani, Director, TCI

The CRC evaluate the case on the basis of submissions made by the applicant, duly forwarded by the procuring agency, and criteria laid down in Expression of Interest (EOI), and bear no responsibility towards the authenticity of the received documents.

Finding:

The Committee after having detail review of the submission made by the applicant (M/s Gresham Eastern (Pvt.) Ltd.) has concluded the following:

- The applicant failed to produce the evidence of mandatory "Registration with SBR"
- The applicant have failed to demonstrate experience in similar nature of work, with respect to construction and management.
- The applicant's average annual turnover for the last 2 years is far less than what specified in prequalification document.

In the light of above evaluation, CRC is of considered opinion that despite revisiting all categories of evaluation criteria, the applicant hereby fails to prequalify.

Decision:

The Prequalification Documents submitted by M/s Gresham's Eastern (Pvt.) Ltd, fails to qualify the baseline of shortlisting criteria, thereby declared "not qualified"
