The Sindh Solid Waste Management Board invited tenders for 'RE-INVITATION OF REQUEST FOR PROPOSALS FOR DIFFERENT CONSULTANCY SERVICES' UNDER TENDER REFERENCE NO. RE-NIT-8 /2016-17.

2. Sindh Solid Waste Management Board repeatedly requested the Finance Department for nomination of an officer of BS-18 to act as Member of Consultants Selection Committee, but the Finance Department assigned this task to Section Officer of BS-17. SPPRA raised objection on nomination of BS-17 Officer by the Finance Department in the Consultants Selection Committee instead of BS-18 Officer. The issue was again taken up with Finance Department and now the Finance Department, Govt. of Sindh, vide letter No. FD.SO(DEV-VI)10(4)/Meeting/ 2017-18 dated 30th August 2017 has been pleased to nominate the Deputy Secretary (Dev-II), BS-18, Finance Department as Member of Consultant Selection Committee of Sindh Solid Waste Management Board (copy attached).

3. Recently SPPRA vide letter No. A.D. (Assess)/SPPRA/31905/2017/874 dated 19th September 2017 has desired to rectify the reports of works under NIT-8, which were earlier signed by the Section Officer, BS-17 of Finance Department instead of BS-18 officer as required under SPP Rules 2010 (Amended 2017).

4. In view of the above observation raised by SPPRA, the work namely 'Re-Invitation of Request for Proposals for different Consultancy Services' under tender reference No. Re-NIT-8 of 2016-17 is hereby cancelled. The same shall again be re-invited in order to comply with the observations of SPPRA.


SUBJECT: NIT NO SSWMB/NIT-8, Dated. 28.02.2017, Sr# 31905.
