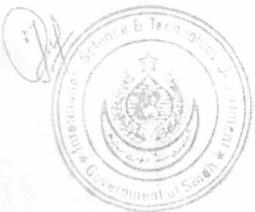

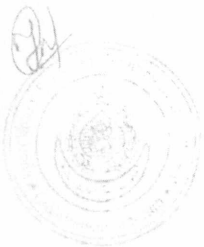

1. RFP ADDENDUM

The Information, Science & Technology Department, Government of Sindh hereby issues this RFP Addendum to set out the following changes and amendments to the RFP previously circulated in respect of the Project, which amendments and changes shall stand incorporated in the RFP. Notwithstanding anything to the contrary, all relevant provisions of the RFP shall stand amended to the extent required to give effect to the matters set out in this RFP Addendum.

*Unless expressly specified otherwise, all capitalized terms used herein shall bear the meaning ascribed thereto in the RFP.*

1.1 *The following clarifications/changes/deletion of the RFP on the suggestions of shortlisted bidders during the Pre-Bid meeting held on 22.5.2017.*

1.1(a) The word 'Deployment' given at Bid Data Sheet Page No. 34, Point No 8 and the same word 'Deployment' in Evaluation Criteria at Page No. 34, Point No. 3.1 & 3.2 has been deleted).

(b) The word 'Execetion' at Page No. 48, Point No. 4.1 has been deleted.

1.2 Page No. 33 of Bid Data Sheet Sr. No. 21(4), *"that the firms is not blacklisted and involved in any active litigation and involved in any illegal activities in Pakistan". It has been clarified that the bidders in case of JV, should be endorsed and submitted duly signed in the form of single affidavit at the time of submission of Technical Bid.*

1.3 Page No. 33 of Bid Data Sheet Sr. No. 21(5) has been deleted due to already mentioned in evaluation criteria and counted as marking accordingly.

1.4 Page No. 46 of Evaluation Criteria at Point No. 7.1 has been rephrased as *"The Consultant firm or any of their JV partners must have the ISO 9001 certification"*. The marks shall count read as

ISO 9001 Certification = Yes = 10 marks

ISO 9001 Certification = No = 00 marks

1.4 It has been clarified that list of identified workshop places of Minorities is being providing to the shortlisted firms

1.5 Except as set out herein, all other provisions of the RFP shall remain unchanged.
