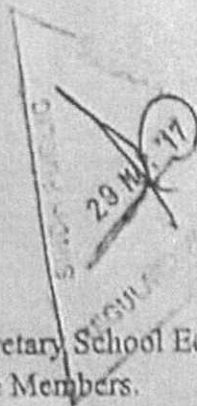
In furtherance of our letter bearing reference No EDU/E&ADS(GA)EDU/E&A/PPP/SBEP/EOI/14/17 dated 28-10-2015, it is reiterated that the EOI for shortlisting of the EDUCATION MANAGEMENT ORGANIZATIONS (EMOs) was published in local newspaper dated 13th May 2015. The same was also hoisted on the websites of the procuring agency (i.e. School Education Department, Government of Sindh (SED-GoS), PPP Unit of the Finance Department and on SPPRA's website.

In response to the EOI published, Twenty (20) applicants were pre-qualified by the TFEC in accordance with the criteria set down in the short listing document. Furthermore, Two (02) RFP were launched in accordance with SPPRA Rules of 2010 and the procurement process for both the RFP's have been concluded.

The Technical and Financial Evaluation Committee (TFEC) of the School Education Department in its meeting dated 15th Feb 2017 (Annexure 1) has accorded its approval for the launch of the Third (03) RFP to be advertised (Annexure 2) through National Competitive Bidding process for Fourteen (14) Public Sector Schools reconstructed with support of USAID under Sindh Basic Education Program (SBEP). The RFP along with the draft Concession Agreement has been approved (Annexure 3-4) & the Annual Procurement Plan attached as (Annexure 5).
