 gued that democracy is a -correcting system provied if it is given space and time. However in Pakistan, ors, ics, apartheid of economic resources, dearth of provision of democrafic rights, apathy omiporities, impassive jodiciary, leaks in public revnues, socio-economic degradation so on and so forth, ave been the common pheomena. Undor such'a situaion, the sense of patriotism significantly declined. One he other side, Pakistan is sruggling from the colossal location of budget to defens and debt servicing. Unde ack of implementafion of irect taxation to cope with the indispensable allocations ecessary for socio-economic amelioration, the country bas ecririgorously trying to mainain sufficient capacity to dea with internal and external challenges. Furthermore, due to insufficient budgetary allo cation to education, the children of our down-trodden society are compelled to get enrolipd into seminaries where modern education is not taugh comprehensively. This gives birth to the closed mind-se and orthodoxy which has become a cause of religiou bigotry and extremist insigh againstothersects. Reportedly there are around 2.5 million Thildren are out-of-school. found radical and opposed to the concept of hation-state akin to that of proscribed militant outfits. They are badly misled by their misinterpreta-
tion of the religious injunctions which has led Pakistan to the state of quaidary of identity crisis. Hence, the dilemma of identity crisis rerpains outstanding varying betweenthe identity ofMuslim or Pakistani either. In addition, the rise and spread of the western propaganda of islamophobia has also creatod an identity crisis in the Muslim world. Usually Muslims are boing recognised by the religion Islam despite the fact that they have dissolved into the western society with the possession of -nationality. Moreover, the denial of human rights to Muslims by France and Germany by prohibiting the use of the Burkini and obligating the hand-shake for Muslim women shows that their democracy is losing its strength and has fallen prone to defects and deficiencies. Similarly. identity crisis is the creation of religious insin--uations, ,western-infosted -Islamophobia and selfimposed perception. This is not a debate as long as democratic Jogalities are implemented in letter and spirit Pakistan is certainly a religious state where minorities -need to respect the religious culture and norms of Muslims, butMuslimsshouldalsorespect the minority's religious culture in reciprocity. Last but not'least, the role of military *has become tangibly professional. The successful transitions of civilian regine uninlerrupted are the harbinger of thriving democracy. Nothing can be mended by itself altogether.
