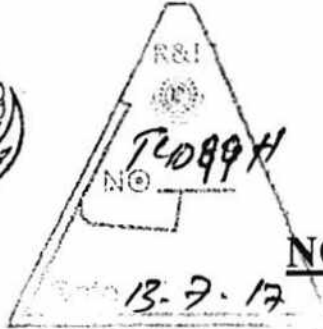
In view of the above clarification it is requested that observation communicated to us vide letter referred above may be withdrawn please.
