

One killed, other injured in separate firing incidents

KARACHI: A man was killed and one other injured in different firing incidents in the metropolis in the wee Thursday. According to rescue sources, an armed man opened fire at a 25-year-old man, Salimullah son of Nawaz Khan near Youself Goth in Baldia Town. As a result, he suffered severe bullet injuries and died on the spot. The body was shifted to Civil Hospital Karachi for an autopsy. Separately, two armed men riding a motorbike opened fire at a 27-year-old unknown man on Kashmiri Road. As a result, he sustained bullet injuries. The injured was rushed to Civil Hospital Karachi for treatment. -Our Reporter

Police arrest nine villagers near Nasirabad

NASIRABAD: Police on Thursday arrested nine people and injured six others during a raid in Allah Dad Chandio village near Nasirabad. Police raided Allah Dad Chandio village, arrested nine villagers and injured six others including women Zahida, Wazeera, Zareena and Heer. The affected villagers demanded justice from Inspector General of Police AD Khawaja and DIG Larkana. They said that their men had been arrested illegally. -Our Reporter

One dead, two injured in Shikarpur truck-bike collision

SHIKARPUR: One person died and two others were seriously injured when an over-speeding truck hit a motorcycle here on Thursday. Police said that a reckless driven truck knocked down a motorcycle carrying three people at National Highway, near Lakhia Ghulam Shah area in Shikarpur district. On motorcycle died on the spot while two others were critically injured who were rushed to hospital for treatment. The truck driver fled from the scene of the accident. The police impounded the truck and after registering a case against the driver at large started raids for his arrest. -Our Reporter
