The bid was comprised on three (03) packages and as per term & condition of contract, every firm must quote all complete packages, and incomplete tender will not be considered as valid.

The Procurement Committee after detailed examination and discussion at the time of opening of bid documents and remarks mentioned above against each bidder decided as follows:-

Decision:-

- Committee has recommended that all tenders may be rejected due to the following reasons:-

1. M/s. Paramount enterprises, Karachi.

That M/s. Paramount Enterprises, Karachi has not quoted rates of all packages. Moreover the makes and details of supply are also not mentioned in bid document. No brochure and supporting documents provided therefore, the tender considered as incomplete and non responsive.

2. M/s. Megaplus Pakistan.

The contracting firm has not submitted his bid on original bid document with their signature which is mandatory required for further consideration. Moreover the firm has quoted only one Package on their letter head instead of prescribed BOQ of bid documents. Hence the same cannot be considered as valid and complete bid.

3. M/s. Aamir Traders.

- I. That rates quoted by the firm are on very high side comparatively from local market. Moreover the make and model or other details are not mentioned. No brochure or leaflet is enclosed.
 - II. The firm quoted all 03 packages with total amount of Rs.30,323,320/-, whereas the budget in the relevant head of account is available only Rs.5.835 in the current financial year 2016-17.
- Committee has also recommended re-inviting a fresh tender (single stage- Two envelopes Technical and Financial Proposals) after scarping this tender process.

The meeting ended with a vote of thanks to and from the Chair.


