SRB's replies to your queries are as follows:

1	According to Rule-50 of SPP Rule-2010 (Amended-2017) procuring agency is required to furnish within 7 days of the award of contract. In the instant case contract awarded on 22-6-2017 and documents received in this authority on 6-7-2017 i.e. after 15 days, hence Rule-50 clarification is required	It is stated that due to Eid Holidays which were from 24 th June 2017 to 28 th June 2017 and the year-end financial closing for the SRB revenue target (PKR 78 billion), SRB could not send the required document within the stipulated time.
2	Procuring agency has not furnished Bill of Quantity(BOQ) of subject NIT items, which is required under-50 (3) of SPP Rules 2017 (Amemnded-2017)	We have already send the BOQ(Schedule of requirements) which was part of the copy of the contract agreement signed with the winning bidder. However, we are again enclosing the copy of the BOQ for your reference.
