

Subject: MINUTES OF THE MEETING REGARDING THE OPENING OF TECHNICAL BIDS FOR THE TENDER FOR PROCUREMENT OF LAPTOP COMPUTERS AND OTHER HARDWARE ACCESSORIES FOR THE AUDITORIUM OF GOVERNMENT OF SINDH FINANCE DEPARTMENT.

Meeting of the Departmental Procurement Committee constituted vide Government of Sindh, Finance Department's Notification No. FD (CTC-I) 04(01)/ 2017-2018 dated 07th July, 2017 was held on 31-07-2017 at 12:00 Noon under the Chairmanship of Additional Finance Secretary (Admin/Sr) in his office on 06th Floor at A.K Lodhi Block Building No.06, in order to undertake the Technical Appraisal of the Bid submitted against the Government of Sindh, Finance Department's Tender Notice published in Three (03) Leading Newspapers namely The Daily English "Dawn, dated 12-07-2017", The Daily Urdu "Express, dated 11-07-2017", The Daily Sindhi "Kawish, dated 15-07-2017" vide NIT Advertisement No. INF/KRY-3374/2017, while the same NIT has also hoisted on Finance Department & SPPRA's official websites with the SPPRA Sr No. 33916, whereas the SPPRA I.D will be released after compliance of Rule-50 i.e. furnishing of Original Bid Evaluation Report, Technical Evaluation Report, Financial Evaluation Report, Form of Contract and Letter of Award & Bill of Quantities to the SPPR Authority.

2. The Committee members were informed that, in response to the Tender advertisement, following Three (03) firms had got the bidding documents issued against a cash of Rs. 1,500/- (non-refundable Tender Fee), that are;

- *M/s. SI Global.*
- *M/s. Premier Systems (Pvt) Ltd.*
- *M/s. Mega-Plus Pakistan.*

3. However, out of the above Three (03) Firms, Only single Bidder namely: *M/s. Mega-Plus Pakistan* has submitted its Bid by the stipulated deadline of 31st July, 2017.


4. The Chairman of the Procurement Committee welcomed the Participant as well as Procurement Committee Members and requested the Procurement Committee members to proceed the Procurement procedure.


5. Being the lone Bidder participation in Tender Process, the Members of the committee advised the Chairman to quash the Tender Process and a Fresh Bids shall be invited by Re-advertisement of Tender Notice.


6. Consequently, as per suggestion of Procurement Committee's Members, the Chairman of the Committee agreed to annul the Tender Process in terms of Rule-25 of SPPRA-2010 (Amended-2017) and returned the Sealed Bids (Technical & Financial) to the Lone Bidder namely: *M/s. Mega-Plus Pakistan*.


