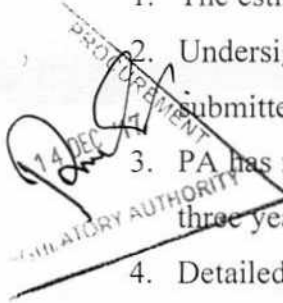

5. Annual Procurement Plane is enclosed herewith on standard format of SPPRA in terms of Rule-11 & 12.
6. NIT not published in leading and widely circulated newspapers due to boycott of APNS by famous/ leading newspapers. Letter of APNS is enclosed for reference).
7. In this tender single stage one envelope procedure is adopted so tender opening date was only 04.10.2017.
8. Lowest bids have been accepted against item numbers 1141, 1167, 2058 & 2184 whereas item number 1169 has not been quoted by any bidder.
9. PA has disposed off all the complaints in terms of Rule-31(6).



10. All the single quoted items are less than the trade price as the PA has mentioned in the terms & condition to ensure that all the prices should be less than trade price, the PA has also checked the price of each & every items which are less than the trade or market price.

11. All the items in the tender are within the Limit as per rule.
