4. Single Stage Two Envelope Procedure would be used for Open Competitive Bidding. In the first stage only the technical proposals will be opened Later, the financial proposals of only the technically qualified firms will be opened. Financial proposals should accompany a bid security equivalent to two percent (2%) of the bid amount in the form specified in the Bidding documents. Both the technical and the financial proposals must be sealed separately. Sindh Enterprise Development Fund reserves the right to reject any or all bids and to annul the bidding process at any time, however, reasons for rejection or annulling bid process will be communicated to the concerned bidder (s) in accordance with the SPP Rule(45) of 2010.

5. The bids prepared in accordance with the instructions in the bidding documents must reach at the office of the Company Secretary, Sindh Enterprise Development Fund, 1st Floor, Block-B, FTC Building, Shahrah-e-Faisal, Karachi on or before 11 A.M. on Thursday 19th October, 2017.
