

Kindly refer to cited notification on the noted subject and it is to state that Technical Bids of Number Plate were initiated and opened on 30.10.2017, it was decided that Technical Committee may evaluate the bids as per evaluation criteria; specification and conditions laid down in the tender document and submit his report with specific recommendations to proceed further in the matter vide No. DVR/(43)Number Plate/2017-18/3173 dated 31.10.2017.


The Technical Committee headed by Deputy Director (ADMN), M. R. Wing, Karachi furnished the technical evaluation report vide No. 1(196)/2016/DG-Tax/Technical Committee/8000 dated 08.12.2017.

Accordingly financial of the technical qualified bid was opened on 12.12.2017 in the Meeting of Procurement Committee for evaluation of the bids. Minutes of Meeting and Bids Evaluation report of the same was sent to SPPRA for hoisting on SPPRA website. The Assistant Director (Assessment), SPPRA raised observation and sought clarification vide No. AD(ASMT)/SPPRA-34789/2017-18/3047 dated 03.01.2018 and No. 4058 dated 17.01.2018. The same were responded and clarified vide No: DVR/MR(43)/Number Plates/2017-18/086 dated 09.01.2018 and 17.01.2018 respectively but bid evaluation report has not been hoisted on SPPRA website till to date. Since 90 days validity period specified in bidding document under Rule 38 of SPPRA Rules 2010 (amended 2017) is to be expired on 27.01.2018 whereas after hoisting of bid evaluation report it will also be required at-least three (03) working days for hoisting of the same on SPPRA website and more time for finalization of further process is also required.
