The procuring agency (PA) has not furnished clear and unambiguous evaluation criteria in bidding documents as required under Rule-21(A) of SPP Rules-2010 (Amended 2017)	The Minimum Qualification Criteria which was attached with bidding documents are clear & unambiguous. <b>(Attached at "Annexure D")</b> .
ii.	Instead of formulating evaluation criteria PA reproduced Rule-46(1)(A) of in bidding documents as evaluation criteria whereas, it is not mentioned that how much minimum relevant experience is required how much annual financial turnover is required for last three years to evaluate the bidders.	The evaluation criteria (Eligibility & Minimum Qualification Criteria) was annexed at "A" whereas bidding process method of SPPRA was separately <b>Annexure "E"</b> .
iii.	Further tentative quantity is also not mentioned in bill of quantity which is required	The price schedule was based on Unit Price whereas the total budget provision, to determine the quantity by bidder himself, was reflected in Price Schedule <b>(Attached at "Annexure C")</b> .
iv.	Schedule of second attempt is not clear PA should clarify mention the schedule of issuance / submission /opening of bids	The 2 <sup>nd</sup> attempt date of sale of tender / dropping was 17 November 2017 & 21 November 2017 respectively as per SPPRA Guideline. The same already mentioned in the NIT published in daily Daily Express (Urdu) dated 14.10.2017, Daily Awami Awaz (Sindhi) dated 14.10.2017 & Daily Dawn (English) dated 14.10.2017 <b>(Attached at "A-3, A-4 &amp; A-5")</b>

### **Minimum Qualification**

The supporting documents for each above qualification criteria shall be duly signed & stamped on each papers & enclosed with the tender documents. No paper shall be accepted after the opening of tender.

Those bids which will meet all Eligibility & Minimum Qualification Criteria shall be declared as "Substantial Responsive Bidder" and their bids will be allowed for its technical & financial.
