MINUTES OF THE MEETING OF PROCUREMENT COMMITTEE HELD ON 30.11.2017 AT 03:00 P.M. TO OPEN THE BIDS INVITED FOR PROCUREMENT OF "BREAKFAST, LUNCH & DINNER" FOR THE BOARD OF INTERMEDIATE EDUCATION KARACHI.

A meeting of the Procurement Committee BIE Karachi was held on 30.11.2017 at 03:00 p.m. in the Committee Room of Board of Intermediate Education Karachi, under the Convenership of Secretary, BIE Karachi to open the bids invited for procurement of (Breakfast, Lunch, Dinner) during the examinations for the staff those engaged/detained twenty four hours in Board of Intermediate Education Karachi. Meeting started with the recitation from Holy Quran. The Committee was informed that the Bids invited through websites for providing the "Breakfast, Dinners & Meals" for the BIE Karachi was opened on 30.11.2017. The Committee was also informed that as per the SPPRA rules 4.3, procurement over One Hundred Thousand Rupees and up to the limit of One Million Rupees shall be advertised by timely notifications on the Authority website as well as procuring agency's website. Accordingly to the above rules, the sealed bids/quotations were invited through hoisted procuring agency's website and SPPRA website as on 08.11.2017 at serial No.35157.

In response to advertisement, four (04) interested firms purchased the tender documents, out of which only three (03) bidders submitted their bids (Attendance Sheet annexed at "A"), which are as follows:

- 1) M/s. Bilal International, Karachi
- 2) M/s. Ainee Catering Services, Karachi
- 3) M/s. Zaib Enterprises, Karachi

The bid was opened by the Procurement Committee on 30.11.2017 in presence of the representative of Bidding Firms and the rate quoted by bidders was announced. Committee preliminary evaluated the bid technically with regard to availability of required documents; viz. NTN and Sales Tax Registration, business experience and dealing of firms in supply of similar stores, committee has satisfied after preliminary evaluation of the documents submitted by the bidders.

As per the SPPRA rules, the rates quoted by all the three firms were announced by Committee in the presence of bidders and the "Financial Statement" of rates quoted by all the bidding firms have been prepared by the committee, as annexed at "B". The summarized position of the Financial Proposals is given as follows:-

During the discussion, Mr. Babar Shah, member committee has pointed out the above bidders have quoted the rates for providing the "Meals, Dinners & Lunch" is seem to be unjustified and which is shown the rates quoted by the firms very higher side and bidders offered the rates more than 1.00 million, which means beyond then tender limit, if contract shall be materialized in any case which means Board's exchequer may sustain heavy loss. Accordingly, the procurement committee has supported to Mr. Baber Shah, and deeply discussed into the matter. Finally the committee has decided to invite the proposals through the re-tendering process during the conducting Annual Examination for the year 2018 and as for as the Supplementary Examination 2017, pervious practice prevailing in the board may be continued.


DECISION:




