Procuring Agency (PA) has furnished two different criterias at page 8 and 17 of Bidding document in which most of criteria are same however; at page 08 these criteria have allocated marks whereas; at page 17 the same criteria is mentioned as mandatory like NTN, GST, Turnover etc. Beside, regarding experience PA required P.O of last year having allocated marks and 02 and the same is mentioned at page 17 as at least five contract.	Due to conflict/correction following para of Page No.17 – Bid data sheet removed/amended. Sr. No.02 as mentioned in Page No.8 -2.c copy of purchase orders of last year (worth > 15.000 Million) Sr. No.4 – 3.d as mentioned in Page No.8 Turnover last year more than 40.000 million Sr. No.4.6 removed.
ii.	Similarly, minimum marks for qualification are 65 but minimum marks in each section are not given.	Page No.8 every section of evaluation criteria qualification marks are 50%
iii.	Section 6.1 of Bid Data Sheet is in conflict with Rule-23(i) also in section 10 of Bid data sheet.	Page No.17-6.1 will be followed as Rule –23(1) as per SPPRA Rules 2010(amended 2017) Sr. No.10 – phrase read as “Lowest evaluated bid”
iv.	Section 4(5) of bid data sheet needs clarification as to how are terms well known, well defined, well reputed shall be determined.	To produce satisfaction certificate for quoted product any Government/non Government institutions (not mandatory)
v.	Complaint/observation	Complaint/observations so received were already compliance/replied and sent to complaineé also SPPRA Department by PA (copies attached)
