I am directed to refer to the subject noted above and to state that Technical Member, Video Conferencing Engineer, Information & Technology Department submitted Technical Evaluation regarding procurement/installation of Sound System at Cabinet Committee Room, 7th Floor, Sindh Secretariat Building No.1, Karachi, wherein it has been stated that after thoroughly reviewing of submitted technical documents of the companies, which reveals that both companies have not met the required mandatory criteria. Technical Member also proposed that the procurement of above said tender may be re-called through specified process of SPPRA Rules (copy enclosed).

A meeting of the Departmental Procurement-cum-Technical Committee was held on 17.01.2018 at 03:00 p.m. under the Chairmanship of Additional Secretary (GA), SGA&CD to examine and scrutinize the "Technical Evaluation/eligibility Report". After detailed deliberations on the subject matter, the Procurement-cum-Technical (A) Committee has observed that both bidders have not qualified/eligible as per tender specification as they have not met the mandatory eligibility criteria as per NIT, the Committee unanimously decided that the tender may be cancelled as per SPPRA Rules (copy of minutes of the meeting is enclosed for ready reference).

> On the recommendation of the Departmental Procurementcum-Technical Committee, the Competent Authority has been cancelled the Tender Notice NO.4819/17 dated 16.11.2017 and re-called/ re-tender.

MINUTES OF THE MEETING REGARDING REPLACEMENT OF SOUND SYSTEM INSTALLED AT THE CABINET ROOM, 7TH FLOOR. NEW SINDH SECRETARIAT

A meeting of the Departmental Procurement Committee was held on 17-01-2018 at 03:00 p.m. under the Chairmanship of Additional Secretary (GA), SGA&CD to discuss the Technical Evaluation Report' submitted by the Technical Member / Video Conferencing Engineer, Information Technology Department regarding replacement of Sound System and installation of multimedia at the Cabinet Room, 7th Floor, Sindh Secretariat Building No. 1 The list of participants is attached.

- Technical Evaluation Report reveals that after thorough scrutiny of documents provided by the participating bidders M/s. Pakistan Civil & Electric Works and M/s. Silk Engineering, both haven't met the mandatory eligibility criteria as per NIT. (Para-2 of the Technical report) hence no any company has qualified for the tender. Furthermore, it is also informed that the above two companies have participated earlier as well, whereas both haven't completed required mandatory eligibility criteria and the tender was cancelled. Now they've again submitted their bids during the current tender and again they've not met the standard required criteria and disqualified.
- After detailed deliberations by the Purchase-cum-Procurement committee, it was decided that the current tender process for procurement of sound system & its installation at cabinet committee room, 7th floor, Sindh Secretariat Building #1 may be cancelled, as no any company has met the eligibility criteria. The Committee further proposed that fresh NIT may be called The 'financial proposals' kept sealed may be returned to the concerned firms / companies.

The Procurement-cum-Technical Committee unanimously agreed on above decision. Meeting ended with vote of thanks to and from the chair.
