- Amount of Annual Turn-over Rs. 1,000 million is mentioned in the NIT due to oversight, however, estimated cost Rs. 0.500 Million of the work is mentioned in bid data sheet.

It is further informed that no vender has purchased the tender, therefore, the same has already been cancelled. Also, while inviting fresh tender due care would be taken in light of observations raised in the above referred letter.

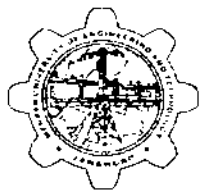
