I am directed to refer to your letter under reference and to submit the following replies for your consideration:

- i. The observation pointed out by SPPRA is received after hoisting of NIT on website of SPPRA as well as after opening of Tender.
 - ii. As per Standard Bidding Document available on SPPRA website, the bid Data Sheet is required to be submitted for Procurement of Goods only, Whereas all information required as per Data Sheet is available in every Bid Document of NIT-10.1, 10.2, 10.3 and 10.4. Further, it is submitted that the subject tender is under category for procurement of services and not goods.
 - iii. To check the Financial position / capability of the bidder as required under SPPRA Rule-46(1), the information was asked from the bidder in Eligibility Criteria at column No. 7 of bidding document.
 - vi. The quantity of Garbage per day is mentioned in column of BoQ, However, due to variation of incoming garbage at GTS, the quantity may vary upto + or - 25% as mentioned in BoQ. This information was mentioned in bidding document, so that the bidders have an idea of incoming garbage at GTS and which ultimately to be transported / lifted to the Landfill Site.
2. In view of the above clarification, it is requested that the infirmities raised by Sindh Public Procurement Regulatory Authority may be cleared.
