The clarification of points raised in the above referred letter is submitted

here under;-

1. The Time for dropping and opening of tenders was kept after considering the break for **ZUHAR** Prayer, which is usually preformed in Dadu Town between 1.30 PM to 2.00 PM
2. The column has not filled erroneously. However in sets of documents provided to the contractors, dates times were mentioned clearly.
3. The Bank statements were obtained with a view to asses, financial status of contractors. However exist amount of turn-over was not mentioned. In future this condition will be adhered to strictly.
4. It is clarified that in all two attempts no one has participated in bidding process of these (26) works and same will be re-advertised in due course of time. Such information has been submitted previously, a copy of which is appended.
5. The works in respect of which, bids were invited are below Rs.4.00 (M) value, hence column was kept blank and no one was required to submit registration certificate.

In view of above, it is, requested that clarification may be considered and observation may be sat-aside , so that further process for implementation of NIT may be completed and works of public welfare may be got executed.
