

- iii. Valid License issued from Inspectorate of Electrical License Sindh of the similar region with respect to work shown at S.No.4 to 20.
- iv. Not more than (02) tenders will be issued to one firm.
- v. Registration with Income Tax Department, Sindh Revenue Board, Sales Tax department.
- vi. The application Shall accompany of tender fee as shown against each for purchase of bidding documents.
- vii. The 2% Earnest Money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding documents in favor of undersigned.
