- All aforementioned technical bids were properly sealed and opened before the bidders and procurement committee, all members have signed the technical bid, whereas all sealed financial bid were kept un-opened
- 3. It was informed to all bidders that submitted technical bid will be sent to Consultant NESPAK for detailed evaluation. M.D (SMTA) further said that only financial bid of technically qualified bids shall be opened, financial bid if found technically non-responsive, shall be returned un-opened to the respective bidders as per SPPRA rules.

2nd MINUTES OF PROCUREMENT COMMITTEE MEETING FOR THE CONTSRUCTION OF BOUNDARY FENCING ALONG ITS EXISTING ALIGNMENT OF KARACHI CIRCULAR RAILWAY (KCR)

The Procurement Committee meeting for the Construction of Boundary Fencing along existing Alignment of Karachi Circular Railway (KCR) [the Project] was held on 13th August, 2018 at 15:00 hours [Committee Room]. PMU Office - Sindh Mass Transit Authority (SMTA), Government Of Sindh, III Talwar Chinon Karachi under the chairmanship of Managing Director (SMTA), the meeting was convened to discuss the technical evaluation report of the project submitted by consultant M/s NESPAK. List of participants is attached as (Annexure "A").

Notice Inviting Tender (NIT) was published in daily newspaper i.e. Dawn, Jang and Kawish on 14th February. 2018 and subsequently hoisted on SPPRA website.

- 1. Managing Director (SMTA), GoS initiated the meeting by welcoming all the participants. It was informed to the committee that the project consultant M/s NESPAK has submitted the technical evaluation report of following three bidders.
 - a. M/S Haji Syed Ameer & Brothers.
 - b. M/S Ghause Builders.
 - c. M/S Super Traders.
- 2. Technical Evaluation report was presented before the committee, and informed that only one bidder has qualified i.e. M/s Haji Syed Ameer and Brothers. However, M/s Ghause Builders and M/s Super traders could not be qualified in the initial scrutiny. Detail of initial scrutiny is as under.
