Point-wise reply/clarification to the observation made vide letter under reference regarding the subject NIT is as under:-

- i. It is true that the estimated cost of Rs.1.00 Million has been mentioned in the Bid Data Sheet while Rs.8 lacs mentioned in the APP. In this connection, it is to state that estimated cost has been determined on the basis of the cost of the items prevalent in the market, whereas, the NIT was called on offer rate basis as per usual practice. That is why there is variation in figure. It is, however, clarified that the quantity of the items will be reduced proportionately while finalizing the case so as to restrict the expenditure within the ambit of allocated fund.
- ii. The Bidders Qualification Report has been prepared on the basis of the Qualification Criteria mentioned in the NIT. However, the point has been noted for strict compliance in future. The BQR showing compliance of the mandatory requirement as per NIT is enclosed.
- iii. Detailed Comparative Statement as per Bill of Quantities mentioning description and quantity of items is enclosed.

In view of the above clarification, it is requested that the documents being enclosed may kindly be uploaded on the website, please.




