- iv. The date of submission and opening of Bid mentioned in NIT i.e. **26-03-2018** is correct. But due to typographic mistake in Bid Data Sheet, the date for submission and opening is incorrect. Therefore the date i.e. 27-02-2018 may be read as **26-03-2018**.
- v. The Bid Security in NIT i.e. 2% is correct and the Bid security mentioned in Bid Data Sheet i.e. 2.5% is incorrect due to typographic mistake, which may be read as 2%. In this connection this office has already clarified to the concerned Bidders vide Letter Dated 19-03-2018. (Copy enclosed)
- vi. The amount of financial turnover has not been mentioned in Eligibility Criteria of bidders because of the reasons that the cost of each NIT is less than 1 Million. However, Annual Income Tax return for last 3 years is included in the evaluation and qualification criteria for the assessment of their financial turnover.

In view of your observations, the infirmities were rectified. The copies of documents are attached as required.

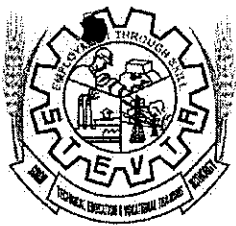
