	Procuring Agency opted International Competent Bidding for the subject procurement, for which approval of the Head of Department is required under Rule 15(2) (a) (iii) as the estimated cost of procurement is less than US Dollar 10 million	The Department has opted with the approval of Head of the Department for International Competitive Bidding for procurement of Contraceptives in terms of Rule 15 (2) (iii) as the contraceptive commodities like i.e. Condom, IUCD, Implants are not manufactured in Pakistan and the manufactures participate in international bidding only if the payment is ensured to them through irrevocable Letter of Credit. Moreover if the same commodities are procured through authorized agents by method of national competitive bidding the price of the commodities would be three times higher as compared with international competitive bidding. The department due to aforementioned reasons and in order to get best value of money has opted for ICB.
	In the evaluation criteria procuring agency mentioned that annual turnover should be at least five times of the estimated cost contract value, which is very high and difficult condition and restrict the contractors to participate.	Since in the instant competitive bidding only the manufacturers registered with WHO & UNFPA are eligible to participate, therefore the requirement of Annual turnover at least five times of the estimated cost contract value is neither very high nor difficult condition. The manufactures having good quality standards and financial soundness are and turnovers are approved by WHO for the supply of contraceptives globally.
