Replies to observations are furnished below:-

01. It is not true, we have issued work order after 03 days of the hoisting of Bid evaluation report at SPPRA website (Documentary proof attached). Hence rule is not violated.
02. This office has already explained the emergent situation faced by this office as education works was assigned the task of providing lacking facilities to the schools declared as polling station. Having less staff and very limited resources this gigantic assignment and National cause was met up by giving all our time day & night and working on holidays. However the results of procurement were hoisted on our office Notice board. The delay was not meant for misprocurement, but this lapse occurred done to rush of work, hence the mistake may be waived and reasons mentioned may be considered upon sympathetically.
03. The details of works at Sr. No: 01,02,03,04 & 05 are given below.
Work at Sr: No. 01 & Sr: No. 05 were not approved by competent authority i-e, Chief Engineer Education Works Hyderabad rejected the bid as the lowest quoted amount was more than 30% below the engineers estimate (copy of tender rejected attached).
Whereas works at Sr:No: 02,03 and 4 were not awarded to contractors as the committed funds were not released by Finance Department, hence contracts were not awarded (Documents attached).

This is for your kind information and taking further necessary action.
