1	Procuring Agency Awarded Contract on 06.06.2018 and 11.06.2018, whereas this Authority has received Contract Documents after 20 days. It is mandatory to host the documents within seven days in term of Rule 50 SPP Rules 2010 (amended 2017) P.A has violated SPP Rules.	This authority has issued award of contract from 06.06.2018, vendors have received the letter of award of contract from the office on later dates and last letter of award of contract was received by vendors on 11.06.2018. Accordingly, after receiving of the letter of award of contracts, the Authority signed the contracts / agreements during the prescribed time period of three working days after receiving of agreements of said NIT. There were 15 contracts in total and the first contract agreement was signed on 08.06.2018, whereas other contract agreements signed on different dates and last contract agreement was signed on 19.06.2018. Furthermore, as per contract agreement supplier submitted performance security after signing of the contract in their respective dates. There were also Eid holidays from 15 th to 18 th June 2018. Since, the last such contract agreement was signed on 19.06.2018, and the consolidated contract evaluation form of the entire contract was submitted on 22.06.2018, as such to our standing no delay occurred in submitting the Contract Evaluation Form.

In view of the above, it is requested that the aforementioned observations may kindly be cleared on the above stated grounds / factual position of the case.
