
Objection	Justification
The Quoted Projector is Short Throw not an Ultra Short Throw as Required	
1. The Quoted Model PT-TW351R has not 3 HDMI Input Required in BOQ	The HDMI inputs check was an over sight as there were 3 inputs of different types
2. The Quoted Projector is only Pen/Pointer Touch not Finger/Pen touch	We demanded Pen/Finger touch but the Panasonic have pen touch function so it was considered by committee.
3. The Quoted Model PT-TW351R has not 3 HDMI Input Required in BOQ	objection 1 is repeated
4. Panasonic Quoted Projector does not have Split Screen Feature	As per the vender the functionality is available in their model which will be demonstrated as the sample will reach.
5. PT-TW351 has Speaker only 10W required Speaker 16 Watts	The vender has quoted external 16 watt speakers
6. PT-TW351 Not MHL Supported for Mobile Connectivity	As per the vender the functionality is available in their model which will be demonstrated as the sample will reach.
7. Required HDMI Inputs 3 PT-TW351R has only 1	objection 1 is repeated


5. After detailed deliberation the Chairman and Committee members decided the following:-


