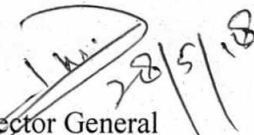

### 3. **DEFINITIONS**

**“Agreement Signing Date”** means the date on which the Contract Agreement is executed between the Sindh Livestock Registration and Trade Authority Government of Sindh and the Bidder

**“Bid”** means the proposals submitted by the Bidders in response to the RFP / Tender Document.

**“Bid Process”** means the various activities leading up to the selection of the Lowest Evaluated Bidder, including without limitation, the issuance of the RFP / Tender Document, submission of Bids, and scrutiny and evaluation of such Bids

**“Bid Security”** means the Bid Security paid by the Bidders in the shape of Demand Draft or Bank Guarantee from any scheduled bank in Pakistan as in terms of Clause 5.17.1 of this RFP / Tender Document.

**“Bidder”** means Bidding Company/Joint Venture, as defined below that has submitted a Bid in response to this RFP/ Tender Document.

**“Contract Period”** means duration of the contract agreement i.e. 3 years from the Contract Commencement Date extendable with mutual consent of Bidder/Joint Venture and Sindh Livestock Registration and Trade Authority in response to this RFP / Tender Document.

**“RFID”** means Radio Frequency Identification Device

**“RFID Tags”** means (One RFID and one Visual Tag per animal) RFID tags for Bovine and Ovine animals identification, manufactured by a manufacturer with “Full ICAR Certification” for Device Composition and Environmental Performance according to ICAR standards, including Conformance with ISO standards 11784 and 11785 and meeting the other technical specifications set out at Chapter 18 (Technical Specifications) of this document.

**“Joint Venture”** means consortium/JV is allowed but not more than three (03) companies

**“Bid Due Date”** means last date to submit the bid, which is given in Clause 5.9 of Part I of the RFP / Tender Document.

**“Capability”** means the technical and financial capability of the Bidder to be assessed in accordance with Clause 5.1.1 of Part I of the RFP / Tender Document.

**“Competent Authority”** means an authorized officer of the Director General, Sindh Livestock Registration and Trade Authority, Government of Sindh to exercise financial powers and approve the award of contract

**“Contract Agreement”** means The Agreement through which Sindh Livestock Registration and Trade Authority, Government of Sindh will grant to the Bidder the rights to develop the Project

**“Corrupt and Fraudulent Practices”** means Corrupt and fraudulent practices including but not limited to such corrupt and fraudulent practices as described under the Sindh Public Procurement Rules, 2010 (as Amended from time to time)

**“Eligible Entity”** means an Eligible Entity is one, which satisfies at least one of the following:

- The entity is a Company under the Ordinance or an incorporated entity under equivalent Acts, in case of foreign entities. OR

**“Procurement Committee”** means the Committee appointed under the Chairmanship of the Purchase committee, the Sindh Livestock Registration and Trade Authority and consisting of senior officials of the Sindh Livestock Registration and Trade Authority and other technical and financial experts responsible for evaluating the technical proposals of the Bidders including the concept plan and designs.

**“Financial Bid”** means Financial Bid submitted by a Bidder as specified in **Clause 5.25** of this RFP / Tender Document.

**“Letter of Intent (LOI)”** means letter to be issued to the Lowest Evaluated Bidder inviting it to sign the **Contract Agreement** on fulfilment of the conditions laid out in this RFP / Tender document.

**“Performance Security”** means the Performance Security paid by the Bidders in shape of Demand Draft/Bank Guarantee from any scheduled bank in Pakistan as in terms of clause 5.17.2 of this RFP.

**“Successful Bidder”** means the Lowest Evaluated Bidder ranked no. 1 as per the process set out in Section 5.25.3 of the RFP / Tender Document.

**“Ordinance”** means The Companies Ordinance, 1984

**“Principal”** means manufacturer of RFID Tags as described in Technical specification

**“Contract”** means the Contract refers to agreement to be entered into by and between Lowest Evaluated Bidder and the Sindh Livestock Registration and Trade Authority, Government of Sindh for the *“provision/supply of RFID animal tags, affixation thereof and Registration and Development of database of Farms and Animals in Karachi and Hyderabad Divisions”* as per the conditions of the RFP / Tender Document, any subsequent detailed document provided by the Sindh Livestock Registration and Trade Authority, Government of Sindh as part of the Bid Process, and as per the terms of the Contract Agreement between the Bidder and the Sindh Livestock Registration and Trade Authority, Government of Sindh.

**“Contract Cost”** means the total cost of the Project for achievement of project completion, as submitted by the Lowest Evaluated Bidder as part of its Bid during the Bidding process, which has been accepted by the Sindh Livestock Registration and Trade Authority GoS pursuant to the Letter of Intent and as is revised from time to time.

**“Contract Commencement Date”** means the date when the Sindh Livestock Registration and Trade Authority GoS has executed the Contract with the Lowest Evaluated Bidder.

**“Quoted Bid Amount”** means the amount quoted by the Bidder in the Financial Bid.

**“Qualified Bidders”** means bidders who are technically qualified / short-listed as per eligibility criteria and mandatory clauses after the evaluation of the Technical Bid.

**“Request for Proposal (RFP)”** means the Request for Proposal (RFP) / Tender Document refers to this document, issued to the interested Bidders by the Sindh Livestock Registration and Trade Authority Government of Sindh.

**“Selection Process”** means same as 'Bid Process'.

**“Technical Bid”** means submitted by a Bidder in terms of Clause 5.24 of this RFP / Tender Document.



#### **4. PROJECT CONCEPT**

##### **4.1 BACKGROUND**

The overall objective of the project is to implement a regime of animal and farm registration together with animal health monitoring and management protocols to ensure quality milk and meat production, food safety and security; animal ownership security and processing through accredited traceability structures which will additionally enable and improve chances of export of animal and animal origin food to the developed nations, especially for high value markets.

##### **4.2 BRIEF OVERVIEW**

Specific Objectives:

1. Establishment of database for animal registration guided by the relevant ICAR parameters which is based on tagging of individual livestock animals and results in documenting the events involved in Sindh's proposed animal health management system in line with international requirements.
2. Livestock and Farm registration with implementation of protocols for quality livestock, meat, and dairy production through the tagging process.

SCOPE AND LONG TERM OBJECTIVES:

1. To ensure the development of an animal health management system on sound lines by putting in place the technology required to develop a secure food chain for meat and milk which will ensure public health in the long term by providing any authority tasked with this objective the technical ability to perform its functions.
2. To enable farmers to acquire the means to develop the livestock industry in a manner which enables them to export to high value markets like European markets and earn precious foreign exchange and in the process providing better employment prospects in rural areas thereby linking rural economies and reducing rural-urban migration.
3. Developing Disease-Free Zones for Livestock across Sindh and ensuring that movement of Animals is structured to ensure the sanctity of such zones and eventually reaching the objective of a largely disease free environment in Sindh.

To achieve the above, animal identification and registration through tagging needs to be implemented as a Pilot Project within Karachi Division, which shall be implemented within 3 years or tagging 5,000,000 animals whichever comes first. In case Karachi District is covered before the end of this time period, the Division(s) of Hyderabad and Nawabshah can be included until the Pilot Project comes to an end, i.e. within 3 years or tagging 5,000,000 animals, whichever comes first.

#### **5. INSTRUCTIONS TO BIDDERS**

## 5.1 GENERAL RULES

### 5.1.1 Eligible Applicant

- (1) The Company / Firm must:
  - a. Be duly incorporated /registered under relevant national or international laws; and
  - b. Application on letter head be registered with SRB & FBR (if applicable) in case of the international firms/consortium the same shall be registered with the relevant tax department of the country of their registration or fulfill equivalent international requirements as the case may be.
- (2) Bidder, or in case of Consortium the database providing and operating entity should be an ICAR member or associate member.
- (3) Bidder must have valid Manufacturer Authorization proof or provide a Letter from manufacturer/principal of RFID Tags validating the support, supply, warranty and services as per this RFP / Tender Document.
- (4) The Principal must submit Warranty statement to supply RFID Tags for up to 5,000,000/- in 3 years.
- (5) Bidder and their Principal, and in case of a consortium any member thereof, shall not be blacklisted by any Government/Authority and is never involved in any unsuccessful litigation/ Arbitration with any Govt. Department/ Authority or Autonomous Institution in respect of any supply similar or identical to this RFP / Tender Document.
- (6) The bidder should have, neither failed to perform on any agreement, as evidence by imposition of a penalty or departmental inquiry by an arbitral or judicial forum.
- (7) Bidder shall not be under a declaration of ineligibility for corrupt and fraudulent practices in terms of Rule 30 of SPPRA 2010 (Amended 2017) local or international level.
- (8) Bidder should submit the List of clients (national or international level).
- (9) Bidder should submit the Customers satisfaction proof/evidence (national or international level for similar projects).
- (10) The Bidder must be having experience of manufacturing and supply RFID Tags

(Based on International Experience) projects (local or international)  
(completed/on-going)

- (11) All documents must be submitted in English.
- (12) All the documents should be comprehensively complied in all respects.
- (13) Proposal may be declared non-responsive if all the annexures as mentioned in the Technical Proposal are not submitted in the same order.
- (14) Provide undertakings on oath as required on Application Submission Form.
- (15) Provide certified copies of all supporting documents requested under the Application Form.
- (16) Failure to provide certified documents meeting mandatory requirements mentioned and Application Submission Form will lead to outright rejection of the application/bid.
- (17) As the part of the technical evaluation process, any firm / company may be asked to clarify its answers or provide more details if required.
- (18) Sindh Livestock Registration and Trade Authority, Government of Sindh will examine the documents to determine completeness, general orderlies and sufficiency of response. Failure to complete the documents and/ to provide written answers to any further questions or requested additional information for clarification will result in the supplier's elimination from further consideration.
- (19) Please note that by responding to these documents including the Application Form and Data Sheet you accept that all answers are legally binding and if need arise, may be used as evidence in any court of law. Further, Sindh Livestock Registration and Trade Authority, Government of Sindh reserves the right to verify at applicant's cost the accuracy of any answers and documents provided with the Qualification Documents.
- (20) Any information given and found incorrect shall lead to disqualification of the Applicant. The Company/Firm accepts full responsibility and strict liability for making any false declaration, not making full disclosure, misrepresenting facts or taking any action likely to defeat the purpose of this qualification exercise.
- (21) The company / Firm shall observe the highest standard of ethics during whole process of qualification and shall not indulge in fraudulent, corrupt, coercive, collusive and obstructive behavior detrimental to the interest of the Sindh

Government.

- (22) Applicants to kindly note that submission of Qualification Documents does not amount to any contractual obligation on the part of Sindh Livestock Registration and Trade Authority, and that Sindh Livestock Registration and Trade Authority is not obliged to invite bid/quotation from any or all who express interest by responding to this technical & financial qualification process.

- (24) The original documents shall be prepared in indelible ink. It shall contain no interlineations or overwriting, except as necessary to correct errors made by the applicant Company/Firm. Any such corrections must be initialed by the person(s) who sign(s) the Document.
- (25) The completed documents shall be signed off and initialed by Director of the organization, and in case of a consortium the lead member thereof, and rubber stamped on each page and signed on the last page in the space provided.
- (26) Applicants will meet all cost associated with preparation and submission of their applications.
- (27) Canvassing will lead to automatic disqualification of the applicant. Submission is as per instruction given in the Advertisement notice.
- (28) Late submission will not be acceptable. Any application(s) received after the date, time and manner of closure will not be considered.
- (29) Scope of Work should be same at the time of bidding.
- (30) All Procurements shall be made under Sindh Public Procurement Regularity Authority Rules 2010 (as amended from time to time).
- (31) Pass percentage in qualification criteria for the technical part of the bid is 80%
- (32) The Company/Firm shall fill out the relevant part of the Data Sheet in accordance with the certified information provided in the Application Form and strictly as per Evaluation Criteria.
- (33) The Sindh Livestock Registration and Trade Authority reserves the unconditional right to cancel/amend the technical qualification process before submission of technical proposal and can accept and reject any application for technical

qualification on any ground in accordance with Rule 45 of SPPRA. Details and addresses of all the production facilities / sites (disaster recovery plan shall be submitted).

- (34) Bidder/ Principal must submit the 02 (two) samples of RFID Tags including technical Specification along with the bid.
- (35) The bidder is required to qualify the mandatory requirement mentioned above and qualify as per clause 5.24.3 to be eligible to qualify for evaluation.
- (36) Any entity, which has been barred by the Sindh Livestock Registration and Trade Authority, Government of Sindh and any other Government department from participating in projects in Pakistan and if the bar is subsisting as on the Bid Due Date, would not be eligible to submit the Bid, either singly or in Consortium/Principal.

#### **5.1.2 Number of Bids**

Each Bidder shall submit only **(1) Bid, in duplicate (one original and one copy)**, in response to this RFP / Tender Document. Any Bidder submits or participates in more than one Bid will be disqualified.

#### **5.1.3 Bid Preparation Cost**

The Bidder shall be responsible for all of the costs associated with the preparation of its Bid and its participation in this selection process, including, without limitation, any and all costs, direct or indirect incurred in verifying, gathering and collating material, information and data, whether included in the information or not, or on securing the services of advisors and / or consultant, etc. Sindh Livestock Registration and Trade Authority, Government of Sindh will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of this selection process.

#### **5.1.4 Bid Warranty**

- (1) It would be deemed that by submitting the Bid, the Bidder warrants that it has:
  - (a) Made a complete and careful examination of the RFP / Tender document;
  - (b) Received all relevant information requested from the Sindh Livestock Registration and Trade Authority, Government of Sindh;
  - (c) Independently verified all Information received from the Livestock and Fisheries,
- (2) It shall be further deemed that by submitting the Bid to the Sindh Livestock

Registration and Trade Authority, Government of Sindh is entitled to presume the existence of and rely on the afore-stated Bidder warranty.

- (3) Sindh Livestock Registration and Trade Authority, Government of Sindh shall not be liable for any wrongful presumption, mistake or error on the part of the Bidder in respect of the above or in respect of the selection process or Project generally.

#### **5.1.5 Right to Accept Any Bid and to Reject Any or All Bids**

- (1) Notwithstanding anything contained in this RFP / Tender Document, the Sindh Livestock Registration and Trade Authority, Government of Sindh reserves the right to accept or not to accept any Bid and to cancel the Selection Process and/or reject all Bids at any time without any liability or any obligation for such acceptance, non-acceptance, rejection or cancellation. The Sindh Livestock Registration and Trade Authority, Government of Sindh shall announce its decision(s) with respect to the acceptance or non-acceptance of any Bid, rejection of all Bids or cancellation of the Selection Process in accordance with the applicable law and shall return the Bid Security to the Bidders.
- (2) The Sindh Livestock Registration and Trade Authority, Government of Sindh reserves the right to reject any Bid, if at any time a misrepresentation is made or uncovered or any of the covenants, undertakings or assurances made by a Bidder in the Bidding Documents submitted to the Sindh Livestock Registration and Trade Authority, Government of Sindh are found to be untrue, incorrect or misleading. This would lead to the disqualification of the Bidder. If such disqualification and / or rejection occurs after the Financial Bids have been opened and the Lowest Evaluated Bidder gets disqualified and / or rejected, then the Sindh Livestock Registration and Trade Authority, Government of Sindh reserves the right to either:
  - a. Invite the second lowest evaluated Bidder; on the same terms and conditions as were settled with the earlier Bidder; or
  - b. Take any measure as may be deemed fit in the sole discretion of the Sindh Livestock Registration and Trade Authority, Government of Sindh including annulment of entire Selection Process and inviting fresh Bids and / or Proposals.

## **5.2 DOCUMENTS**

### 5.2.1 Clarifications

- (1) A prospective Bidder requiring any clarification in respect of the RFP / Tender document may notify the Sindh Livestock Registration and Trade Authority, Government of Sindh in writing by facsimile, email, or written correspondence.
- (2) The Sindh Livestock Registration and Trade Authority, Government of Sindh may respond to any request for clarification received up to 1300 hours by 1<sup>st</sup> June, 2018. The responses will be sent by fax or email ([dglrta.gos@yahoo.com](mailto:dglrta.gos@yahoo.com)) and shall also be available in the office of Sindh Livestock Registration and Trade Authority, Government of Sindh.
- (3) Copies of the Sindh Livestock Registration and Trade Authority's responses will be forwarded to all the Bidders and would include a description of the enquiry without identifying its source. The Sindh Livestock Registration and Trade Authority, Government of Sindh shall respond to any clarifications as may be requested by the Bidder with 3 (three) calendar days, provided that such clarification is requested at least 5 (five) calendar days before the opening of the Bid.

### 5.2.2 Amendment and Re-Issuance of RFP / Tender Document

- (1) At any time prior to the Bid Due Date, Sindh Livestock Registration and Trade Authority, Government of Sindh may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify or amend the RFP / Tender Document by the issuance of addenda (“**Addenda**” or “**Addendum**”, as the case may be). Any Addendum thus issued will be sent in writing to all the Bidders. In order to afford the Bidder, a reasonable time in which to take an Addendum into account, or for any other reason, the Sindh Livestock Registration and Trade Authority, Government of Sindh may, at its discretion, extend the Bid Due Date.
- (2) The Sindh Livestock Registration and Trade Authority may re-issue the notice inviting tender and the RFP / Tender Document if it is convinced that there is a material infirmity or ambiguity in the RFP / Tender Document, which cannot be addressed without modifying the contents of RFP / Tender Document.
- (3) The Sindh Livestock Registration and Trade Authority, Government of Sindh may re-issue the notice inviting tender and the RFP / Tender Document in case of cancellation of the Bid Process, if any one of the following conditions exists:
  - a. Such an infirmity in the RFP / Tender Document has surfaced that the Sindh Livestock Registration and Trade Authority, Government of Sindh recommends to the Competent Authority that Bids have to be invited afresh;

- b. A case has been declared of mis-procurement under the **Sindh Public Procurement Regularity Authority Rules, 2010 (amended 2017)**

While re-issuing the notice inviting tender and the RFP / Tender Document, the Sindh Livestock Registration and Trade Authority, Government of Sindh may change the specifications and other contents thereof, as it deems appropriate.

### **5.2.3 Declaration from the Bidders**

The Bidders should along with their Bid also furnish to the Sindh Livestock Registration and Trade Authority, Government of Sindh a declaration in the form of an affidavit specifying therein the following particulars, if applicable namely:

- (1) Details of any conviction of the Bidder or where applicable, by a Court of Law under applicable law;
- (2) Details of any conviction of the Bidder with regard to any offence with regard to the security and integrity of the country;
- (3) Details of any Corrupt and Fraudulent Practices that the Bidder (in case of Bidding with Principal) and/or its Director/ Principal /Manager/Employee or any of its Affiliate.
- (4) Details of any litigation/Arbitration/breach that the Bidder and/or its Director/ Principal/Manager/Employee or any of its Affiliate.

Sindh Livestock Registration and Trade Authority, Government of Sindh reserves the right to reject any Bidder based on the declaration provided above. The declaration should be a part of the Technical Bid.

## **5.3 PREPARATION AND SUBMISSION OF BIDS**

### **5.3.1 Language**

The Bid and all related correspondence and documents should be written in English language. Supporting documents and printed literature furnished by Bidder with the Bid may be in any other language provided that they are accompanied by appropriate translations of the pertinent passages in the English language. Supporting materials, which are not translated into English, may not be considered. For the purpose of interpretation and evaluation of the Bid, the English language translation shall prevail.

## **5.4 BIDDING PROCEDURE**



Procedure of bidding Single Stage Two Envelop procedure (RULE 46(2) OF SPPRA 2010 (Amended 2017)

- a. bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal;
- b. envelopes shall be marked as “FINANCIAL PROPOSAL” and “TECHNICAL PROPOSAL” in bold and legible letters to avoid confusion;
- c. initially, only the envelope marked “TECHNICAL PROPOSAL” shall be opened;
- d. envelope marked as “FINANCIAL PROPOSAL” shall be retained in the custody of the procuring agency without being opened;
- e. procuring agency shall evaluate the technical proposal in a manner prescribed in advance, without reference to the price and reject any proposal which does not conform to the specified requirements;
- f. no amendments in the technical proposal shall be permitted during the technical evaluation;
- g. financial proposals of technically qualified bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance;
- h. financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders; and
- i. bid found to be the lowest evaluated bid shall be accepted.

## **5.5 VALIDITY OF BIDS**

Bidders, by submitting the Bid, agree that the Bid shall be valid for a period of One Hundred Twenty days (120) days from the Bid Due Date (the “**Bid Validity Period**”).

## **5.6 EXTENSION OF VALIDITY OF BIDS**

In exceptional circumstances, prior to expiry of the original Bid Validity Period, the Sindh Livestock Registration and Trade Authority, Government of Sindh may, subject to approval of the Competent Authority, request Bidders to extend the Bid Validity Period for a specified additional period. Any such extension shall be in accordance with all applicable laws.

## **5.7 FORMAT AND SIGNING OF BIDS**

The Bidder would provide all the information as per this RFP / Tender Document. Sindh Livestock Registration and Trade Authority, Government of Sindh would evaluate only those Bids that are received in the required format and complete in all respects in terms of the RFP / Tender Document. The Bidder shall prepare one original set of the documents comprising the Bid and clearly marked "ORIGINAL". In addition, the Bidder shall make one (1) copy of the Bid, clearly marked "COPY". In the event of any discrepancy between the original and the copy, the original shall prevail. The Bid and its copy shall be typed or written in indelible ink and each page shall be initialed by the Bidder. All the alterations, omissions, additions, or any other amendments made to the Bid shall be initialed by the person (s) signing the Bid.

## **5.8 SEALING AND MARKING OF TECHNICAL BIDS**

- a. The Bidder shall seal the original and each copy of the Technical Bid in separate envelopes, duly marking the envelopes as "ORIGINAL" and "COPY". The envelopes shall then be sealed in an outer envelope.
  - i. Each envelope shall contain:
  - ii. Covering letter stating clearly the validity of the Bid;
  - iii. Bid in the prescribed formats along with supporting documents;
- b. The envelopes shall clearly bear the following identification - "Technical Bid: "Animal Health Management System".
- c. The Bidder shall seal the original and each copy of the Financial Bid in separate envelopes, duly marking the envelopes as "ORIGINAL" and "COPY". The envelopes shall then be sealed in an outer envelope.
- d. The envelopes shall clearly bear the following identification - "Financial Bid: "Animal Health Management System".
- e. Both the sealed Envelopes for Technical and Commercial Bids shall be placed in another envelope and sealed. This envelope shall clearly bear the following identification - "Bid: RFID Tags – Livestock Zoning Project (Pilot) Sindh"
- f. The envelope shall be addressed to:

- g. If the envelope is not sealed and marked as instructed above, Sindh Livestock Registration and Trade Authority assumes no responsibility for the misplacement or premature opening of the contents of the Bid submitted.
- h. Further, copy of Bid must be submitted in a bound form (spiral bound or any bound form) with all pages numbered serially, along with an index of submissions. In the event, any of the instructions mentioned herein have not been adhered to Sindh Livestock Registration and Trade Authority, Government of Sindh may reject the Bid.

#### **5.9 BID DUE DATE**

The Bids should be submitted no later than 11:00am hours PST on 07-06-2018 at the address provided in clause 5.8 in the manner and form as detailed in this RFP / Tender Document. Bids will be opened at 12 noon on the same date i.e. 07-06-2018 in the presence of available bidders. Bids submitted by either e-mail, facsimile transmission or telex would not be acceptable. Bids submitted after the time stated above will not be entertained for evaluation.

#### **5.10 EXTENSION OF TIME PERIOD FOR SUBMISSION OF BIDS**

Sindh Livestock Registration and Trade Authority, Government of Sindh, at its discretion may extend the deadline for submission of Bids by issuing an addendum to the RFP / Tender Document, if one or all of the following conditions exist;

- (1) If Sindh Livestock Registration and Trade Authority, Government of Sindh is convinced that such extraordinary circumstances have arisen owing to law and order situation or a natural calamity that the deadline should be extended;

#### **5.11 LATE SUBMISSIONS**

Sindh Livestock Registration and Trade Authority, Government of Sindh will not accept for evaluation any Bid received by it after the Bid Due Date for any reason whatsoever.

#### **5.12 CLARIFICATION OF THE BID**

- (1) No Bidder shall be allowed to alter or modify his Bid(s) after the expiry of deadline for the receipt of the Bids;

Provided that Sindh Livestock Registration and Trade Authority, Government of Sindh may ask the Bidders for clarifications needed to evaluate the Bids but shall not permit any Bidder to change the substance or price of the Bid;

- (2) Any request for clarification in the Bid, made by Sindh Livestock Registration and Trade Authority, Government of Sindh shall invariably be in writing. The response to such request shall also be in writing.

## **5.13 EVALUATION OF BID**

### **5.13.1 Opening of Bids**

- (1) The Technical Bids shall be opened within one hour of the deadline for submission of Bids in terms of this RFP / Tender Document;
- (2) All Technical Bids shall be opened publicly in the presence of all the Bidders, or their representatives, who may choose to be present in person, at the time and place specified in this RFP / Tender Document.
- (3) Sindh Livestock Registration and Trade Authority, Government of Sindh shall evaluate all Technical Bids in the manner specified in this RFP / Tender Document, without reference to the Financial Bids and reject any Technical Bid which does not conform to the requirements specified in this RFP / Tender Document.
- (4) The Financial Bids of Bidders (other than Qualified Bidders) shall be returned un-opened to such Bidders.
- (5) All Financial Bids of the Qualified Bidders shall be opened publicly in the presence of all the Qualified Bidders, or their representatives, who may choose to be present in person, at the time and place specified in this RFP / Tender Document;
- (6) All Qualified Bidders in attendance shall sign an attendance sheet;
- (7) Sindh Livestock Registration and Trade Authority, Government of Sindh shall read aloud the name of the Qualified Bidder and total amount of each Financial Bid shall be read aloud and recorded when opened;
- (8) All Bids submitted after the time prescribed as well as those not opened and read out at Bid opening, due to any procedural flaw, shall not be considered, and shall be returned without being opened;

- (9) Sindh Livestock Registration and Trade Authority, Government of Sindh and the Procurement Committee shall encircle the rates and shall sign each and every page of the Financial Bids
- (10) Sindh Livestock Registration and Trade Authority, Government of Sindh and the Procurement Committee shall issue the minutes of the opening of the Bids in accordance with applicable law.

### **5.13.2 Confidentiality**

Information relating to the examination, clarification, evaluation, and recommendation in relation to the Bidders shall not be disclosed to any person not officially concerned with the process. Sindh Livestock Registration and Trade Authority, Government of Sindh will treat all information submitted as part of Bid in confidence and would require all those who have access to such material to treat the same in confidence. Sindh Livestock Registration and Trade Authority, Government of Sindh will not divulge any such information unless it is ordered to do so by any authority that has power under law to require its disclosure. Sindh Livestock Registration and Trade Authority, Government of Sindh however reserves the right to make public disclosure of the names of the Bidders.

### **5.13.3 Tests of responsiveness**

- (1) Prior to evaluation of Bids, Sindh Livestock Registration and Trade Authority, Government of Sindh will determine whether each Bid is responsive to the requirements of the RFP / Tender Document. A Bid shall be considered responsive if it:
  - a. Is received /deemed to be received by the Bid Due Date including any extension thereof pursuant to Clauses 5.9;
  - b. Is signed, sealed and marked as stipulated in Clauses 5.8;
  - c. Is accompanied by the Power of Attorney as specified in section14;
  - d. Contains all the information as requested in the RFP / Tender Document;
  - e. Contains information in formats same as those specified in this RFP / Tender Document;
  - f. Mentions the validity period as set out in Clause 5.5
  - g. Is accompanied by a copy of the receipt of purchase of the RFP / Tender Document.
- (2) Sindh Livestock Registration and Trade Authority, Government of Sindh reserves the

right not to accept for evaluation any Bid which is non-responsive and no request for alteration, modification, substitution or withdrawal shall be entertained by Sindh Livestock Registration and Trade Authority, Government of Sindh in respect of such Bids.

#### **5.13.4 Re-organization or Revision to the Principal arrangements**

- (1) Save as provided under this RFP / Tender Document, for the purposes of meeting qualification requirements of Section 5.1.1 of this RFP / Tender Document, Bidders may consider revision or reorganization of the Bidding principal, on the terms as may be mutually agreed amongst such parties, provided that:
  - a. Such reorganization, revision, inclusion or amendment, as discussed in (1) above, shall only be effective if a prior written approval of the Competent Authority is taken in advance, prior to the submission of Bids under this RFP / Tender Document;
  - b. in case where there is reorganization, revision, inclusion or amendment to the Bidding Principal composition to the effect that requires inclusion of a new Principal, Bidder or otherwise, the same shall be subject to the qualification criteria as laid out under the RFP / Tender Document;
- (2) The decision of the Competent Authority and/or Sindh Livestock Registration and Trade Authority, Government of Sindh in respect of reorganization, revision, inclusion or amendment of the Bidding Principal shall be final and binding on the bidder Company.

#### **5.14 CLARIFICATIONS**

To facilitate evaluation of Bids, Sindh Livestock Registration and Trade Authority, Government of Sindh may, at its sole discretion, seek clarifications in writing from any Bidder regarding its Bid.

#### **5.15 SELECTION/QUALIFIED BIDDERS AND NOTIFICATION**

- (1) After the evaluation of the Technical Bids, Sindh Livestock Registration and Trade Authority, Government of Sindh would announce technical evaluation by hoisting it on SPPRA's website. Qualified Bidders will be notified in writing by Sindh Livestock Registration and Trade Authority, Government of Sindh Simultaneously, Sindh Livestock Registration and Trade Authority, Government of Sindh would notify the unsuccessful Bidders that their Bids didn't obtain the required technical score.
- (2) Sindh Livestock Registration and Trade Authority, Government of Sindh shall

announce the results of the Bids evaluation in accordance with the applicable laws.

## **5.16 GENERAL COMPLIANCE CRITERIA**

5.16.1 The Bidding Company and/or Principal should be Eligible Entities;

5.16.2 Consortium is allowed to bid but not more than three (03) companies;

5.16.3 The Bidder shall notify all changes in the shareholding structure of the Bidding Company/ principal prior to contract award in respect of the Contract terms of this RFP / Tender Document. Such changes may be approved by Sindh Livestock Registration and Trade Authority, Government of Sindh provided the same are carried out in conformity with the terms and conditions of the RFP / Tender Document and do not jeopardize the Bidder's qualification in terms of the RFP / Tender Document.

## **5.17 BID SECURITY TO BE PAID BY THE BIDDERS**

### **5.17.1 Bid Security**

Bidders are required to submit a Demand Draft/Pay Order from any scheduled bank in Pakistan favoring "Sindh Livestock Registration and Trade Authority" payable at Karachi for an amount equal to **2%** of the Total bid value along with their Bids as Bid Security. The Bids, which are not accompanied by the Bid Security, shall be rejected by Sindh Livestock Registration and Trade Authority, Government of Sindh as "Non-Responsive".

Sindh Livestock Registration and Trade Authority, Government of Sindh shall forfeit the Bid Security in full under the following circumstances:

- (1) If the Bidder revokes his Bid at any time during the stipulated Bid Validity Period as per clause 5.5 of Part, I of the RFP / Tender Document (or during the extended Bid Validity Period as per clause 5.6 of this RFP / Tender Document);
- (2) If the Bidder, during the Bid Validity Period:
  - a. Does not comply with any of the terms and/or conditions contained in the RFP / Tender Document, the Bidding Documents and/or subsequent communications from Sindh Livestock Registration and Trade Authority, Government of Sindh in this regard;
  - b. Fails or refuses to execute the Letter of Intent (in the event of the award of the contract to them).
- (3) The Bid Security of the Bidders (other than Technically Qualified Bidders) shall be returned within two weeks of announcement of the Bid evaluation.

- (4) The Bid Security of Technically Qualified Bidders (other than the Lowest Evaluated Bidder) shall be returned on the date on which Sindh Livestock Registration and Trade Authority, Government of Sindh signs the Contract Agreement with the Lowest Evaluated Bidder.
- (5) In case the Bid Process is cancelled, or all Bids are rejected by Sindh Livestock Registration and Trade Authority, Government of Sindh, the Bid Security of all the Bidders will be released/ refunded within one week from the date on which Sindh Livestock Registration and Trade Authority, Government of Sindh cancels the Bid Process or rejects all Bids.

#### **5.17.2 Performance Securities**

The successful bidder has to submit a Performance Security amounting to 3% of the contract price as per Rule 39 of SPPRA Rules 2010 (Amended 2017) which will be renewed or submitted a new bank guarantee till the completion of the contract in the form of Demand Draft or a Bank Guarantee from a scheduled bank, as provided in the Contract Agreement. Validity of performance security shall extend at least ninety days beyond the date of completion of contract to cover defects liability period or maintenance period subject to final acceptance by the procuring agency.

#### **5.18 DOCUMENT EXECUTED OUTSIDE OF PAKISTAN**

Power of Attorney and Joint Venture Agreement must be authorized by a notary public.

#### **5.19 REGULATORY PERMISSION**

With respect to any regulatory permissions/approval that may be required from a regulator/entity (including foreign regulators/entity), if any, as a consequence of the transaction contemplated in this RFP / Tender Document, the same shall be the responsibility of the Lowest Evaluated Bidder and neither Sindh Livestock Registration and Trade Authority, Government of Sindh nor the Transaction Advisors shall provide any assurance in this regard. The Lowest Evaluated Bidder must comply with the requirements of all applicable laws in order to undertake the Project.

#### **5.21 STAMP/TRANSFER DUTIES/TAXES**

The amount of stamp duty/taxes etc. payable in respect of the execution of the Contract Agreement and any other payments applicable shall be paid by the Lowest Evaluated Bidder.



## **5.22 GOVERNING LAW & JURISDICTION**

The RFP / Tender Document shall be governed by and construed in accordance with the laws of Pakistan until execution of the Contract Agreement. The Courts of Pakistan will have exclusive jurisdiction in relation to any claim, dispute or difference concerning them and any matter arising there from.

## **5.23 SELECTION PROCESS**

The selection of the Contractor will be done on the basis of qualification in both Technical and financial bid as follows:

- **Technical Bid – Evaluation of Technical Proposal.**
- **Financial Bid – Evaluation of Financial Bid.**

## **5.24 TECHNICAL BID**

### **5.24.1 Evaluation of Technical Proposal**

The capability and strategy of the Bidder and the quality of proposed plans and designs shall be assessed at this stage. This evaluation shall consist of assessment of the following:

- a) Bidders' Capability and Experience
- b) Qualifying Eligibility Criteria as per clause 5.1.1 is mandatory.
- c) Bidder's Financial Capabilities
- d) Proposed Implementation Plan
- e) Design and Specification
- f) Manufacturing facility

### **5.24.2 Consideration for Evaluation**

The Bidding Company / JV and Principal to be considered for any of the Capability criteria as per the following conditions:

#### **(1) For a Bidding Company**

For evaluation under the various capability criteria, either the strength of the Bidding Company or if it so prefers, the strength of any one JV partner of the Bidding Company/bidding Consortium as a whole shall be considered as representing that of the Bidding Company.

## (2) Disqualification

Even if the Bidders meets the above criteria, they are subject to be disqualified if the Bidders, have:

- a. Made, incorrect, misleading or false representations in the forms, statements and attachments submitted, whether intentionally or unintentionally; or been debarred by Sindh Livestock Registration and Trade Authority.
- b. Not meeting the eligibility criteria and Mandatory Clauses in the RFP / Tender Document

### 5.24.3 Evaluation

- The firm will be selected under quality and cost based selection method (QCBS) and procedures shall be 80% for technical and 20% for financial considered. The Technical Proposal should be submitted using the format specified and shall include duly signed and stamped forms appended with the RFP. This is a mandatory requirement for evaluation of proposals and needs to be filled up carefully.

Proposals, in the Quality Cum Cost Based Selection (QCBS) shall finally be ranked according to their combined technical ( $S_t$ ) and financial ( $S_f$ ) scores using the weights (T- the weight given to the technical proposal, P = the weight given to the financial proposal, and  $T+P=1$ ) stated in the Data Sheet:

$$S = S_t \times T \% + S_f \times P \%$$

The companies successfully meet the mandatory clauses as defined in 5.24.3.1. and other instruction/requirements in the RFP / Tender Document will be considered for evaluation criteria as per 5.24.3.2 of the technical bids and mentioned above. **5.24.4 Qualification Criteria**

Companies passed through the eligibility and mandatory clauses will be considered for technical evaluation.

The maximum score that can be received in the technical capability criteria is 100. Bidders having total score of 80% and above would qualify for the Financial Bid evaluation stage.

**5.25 FINANCIAL BID**

The Financial Bid would be required to be submitted in a sealed cover and in the format as given in this RFP / Tender Document. The Financial Bid of only the Technically Qualified Bidders shall be opened and the Financial Bid of the Bidders who have not been short-listed shall be returned un-opened.

**5.25.1 Evaluation of Financial Bid**

The Financial Bid of only the Qualified Bidders shall be opened and the Financial Bid of the Bidders who have not been short-listed shall be returned un-opened.

**5.25.2 Objective of Financial Bid Evaluation**

The Financial Bid evaluation criterion seeks to identify the entity offering the lowest amount per RFID Tag (upto 5,000,000 RFID Tags) when affixed on an

animal (within 3 three years from the execution of the Contract Agreement) in the Karachi and Hyderabad Division along with the provision of the database.

### **5.25.3 Financial Bid: Evaluation Criteria**

The Financial Bid considered for evaluation shall be ranked in the order of Quoted Bid Amount offered to Sindh Livestock Registration and Trade Authority, Government of Sindh.
