Minutes of the meeting of the Procurement Committee held on 11th July 2018 for Evaluation of Bids for "Development of SMIU Model School and University Academic Blocks at SMIU, City Campus, Karachi (Phase-1: Model School)"

The tender for "Development of SMIU Model School and University Academic Blocks at SMIU, City Campus, Karachi (Phase-1: Model School)" was opened on 6th July 2018 in front of Procurement Committee constituted vide notification No. SMIU/NOT/2018/087 dated 23-5-2018 and representatives of participating Contractors. Out of 05 pre-qualified Contractors to whom the Tender Documents were issued only 02 following contractors returned the filled tender documents:

1. M/s. Manzoor Ahmed
2. M/s. Amcorp Engineering and Construction (Pvt.) Ltd.

The filled tender documents of these contractors were sent to M/s. EA Consulting (Pvt.) Ltd. via letter No. SMIU/P&D/2018-1100 dated 9th July 2019. M/s. EA Consulting (Pvt.) Ltd. evaluated the bids and responded via letter No. EA/986/1589/2018 dated 9th July 2018 in which they concluded that the amount quoted by lowest bidder is not within the allowable limit of 20%. Furthermore both the parties have quoted premium beyond the permissible limits of Composite Schedule of Rates (CSR-2012) Government of Sindh.

This report was discussed by the Procurement Committee. The Committee expressed concerned that 03 bidders out of 05 did not participate in the bidding process, despite the fact that there demand to extend the bidding time was allowed and the bids were opened on 6th July 2018 instead of 29th June 2018.



RECOMMENDATIONS OF PROCUREMENT COMMITTEE ARE AS UNDER: -

After detailed review, the committee expressed deep concerns over non-serious attitude of pre-qualified contractors and unanimously recommended to opt for open tendering of subject scheme as per SPPRA Procurement Regulation No. 7.4 (2) (iii) due to unreasonably high rates quoted by participating parties which caused delay in award of work. M/s. EA Consulting (Pvt.) Ltd. to draft new Notice Inviting Tenders (NIT) for the scheme titled "Development of SMIU Model School and University Academic Blocks at SMIU City Campus Karachi (Phase-1: Model School)" for open tendering.

Furthermore, seeing the current trend by pre-qualified contractors, the committee recommended to cancel the tender for Phase-2 (Academic/IT Block) as well and it will also be invited by open tendering.




