
Hence the Para raised in the above letter, may kindly be dropped, these objections in the light of above replies.

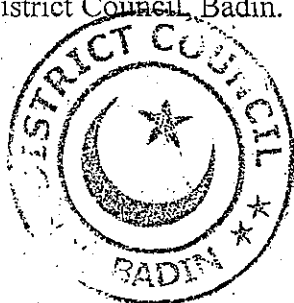
