The replies upon observation are as under:

1.	What is the status of Bid received till the original deadline of bid sub mission mentioned in NIT	Only "One" Bid received till original deadline of bid submission mentioned in NIT
2	What are the reasons for extension in bid opening for Contract Package MS-05under S-III Project	Tender was invited from Pre-Qualified / Shortlisted Contractor's Firm for Contract Package MS-05. In response only one bid received on 29-10-2018 till 1400 hours, the deadline for submission of bid. Procurement Committee unanimously decided to extend the deadline for further 10 days to get a wider competition for bid, (Contract Package MS-05) as per Rule-22 of SPPRA Rule 2010 (amended 2017).
3.	Response time meet to be less than 15 days	Rule-22 of SPPRA Rule 2010 (Amended 2017) Sub-Clause 22(1) allow extension in deadline for bid with the condition that advertisement of such extension in time shall be made in a manner similar to the original advertisement. Hence, a corrigendum issued in this regard mentioning the schedule of bid submission and venue information to comply with SPPRA Rule 2010 (Amended 2017). Also to clarify that fifteen days responsive time is necessary when any material deviation or additional items to be tendered.

Hope the above clarification will remove ambiguity.
