PERMISSION FOR NIT THROUGH PRESS FOR CONTRACT PACKAGES LS-02, LS-03, LS-04 & LS-05 UNDER S-III PROJECT.

There are four Contract Packages in progress under S-III Project through prequalified contractors for Group-A Works. It is observed that out of nine prequalified firms, few are not interested to participate while the pace of work of the contractor engaged is not of the mark and seems not capable to take further contract packages as four more contract packages of Group-A Works, intend to invite tender.

It is suggested open competitive bidding may be adopted for procurement in these contract packages instead of continue with prequalified contractors, but they will be eligible to participate in this O.C.B.

It is, therefore, requested to allow to invite tenders for contract packages LS-02, LS-03, LS-04 & LS-05 of Group - A Works through press in accordance of Clause 15(1) and 46(2) including 15(2)(b)(iii) of SPPRA Rule 2010, which is national competitive bidding as many local companies / firms having vast experience and executed same nature of work in different inational department. Similarly S-II, K-II and K-III projects of KW&SB, executed in last decades are of same nature of works. While in I.C.B high prices and delayed due to law and orders situation would be expected.
