I am directed to refer to the subject NIT received vide letter No: SNDB/HO/ADMN/TD/980-81/2018 dated: 23.10.2018 and to observe that:-

- The CRC is consist of even numbers, which is required in terms of Rule-31(1). Clarification is required.
- ii) Procuring Agency has not included Independent Professional member in C.R.C, which is required in terms of Rule-31(2) (b) of SPP Rules, 2010 (Amended-2017).
- Procuring Agency is advised to address invitation letter to prequalified bidders of instant NIT in the respective bidding documents. Rule-28(g) of SPP Rules stipulates "Only suppliers or contractors, who have been pre-qualified, shall be entitled to participate further in the procurement process".
- iv) Procuring Agency has invited NIT from prequalified bidders but has mentioned in bidding documents that "all the bidders Govt. of Pakistan and Govt. of Sindh shall be eligible" at Instruction to bidder-2(2.2). Rectification is required.
- Procuring Agency is required to mention the name of work with Branch location and full details / address.
- 2. In view of above, Procuring Agency is advised to furnish documents / clarification, at the earliest. It may be noted that it is the sole responsibility of the procuring agency to compliance of SPP Rules, 2010(Amended-2017) in letter and spirit.
- 3. It is further noted that "SPPRA has developed and launched new website 'Procurement Performance Management System (PPMS)'. All Procuring Agencies are advised to use this website for uploading their NIT, BER and Contract documents by themselves, For any query please contact at 021-99205356-99203287."

#### Terms of Reference (TOR)

SPPRA Rule 31 (4). The complaint redressal committee upon receiving a complaint from an aggrieved bidder may, if satisfied;

- (a) Prohibit the procurement committee from acting or deciding in a manner, inconsistent with these rules and regulations;
- (b) Annul in whole or in part, any unauthorized act or decision of the procurement committee; and
- [(bb) Recommend to the Head of Department that the case be declared a mis-procurement if material violation of Act, Rules, Regulations, orders, instructions or any other law relating to public procurement, has been established; and;]
- (c) Reverse any decision of the procurement committee or substitute its own decision for such a decision;

Provided that the complaint redressal committee shall not make any decision to award the contract.

This supersedes previous Office Order #SNDB/ADMIN/HO/01/2018 dated 21-03-2018.
