- 1. The Contract clause 8.1 Bidding Data in Volume-I in Tender Documents which include 7 days should now be dis regarded and shall be replaced with 5 days.
- 2. The word "AND" may be omitted and replaced with "OR" in clause <u>IB 29.2 (a)</u> in the Instruction to Bidder Volume-I of the Tender Documents.

All other Terms & Conditions of the Tender Document for Financial Bidding for the above mentioned project shall remain the same.
