CORRIGENDUM

"The competent Authority may reject all or any bids prior to acceptance of bid under relevant provision of SPP Rules, 2010".

Moreover, in place of condition No.11, the following condition is hereby inserted.
Condition No.11:

"The bidders shall submit their bids in a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal. The first envelope shall be marked as "TECHNICAL PROPOSAL" and second as "FINANCIAL PROPOSAL" in bold and legible letter to avoid confusion under the relevant provision of Rule 46 (2) of SPP Rules, 2010".

However, the date of receipt and opening of the tenders invited as per Tender Notice No. F-Tender (Gen.) 2011-12/ 09 dated 19-02-2011 published in newspapers on 22-02-2011 is hereby extended upto 29th March 2011.

Accordingly, the blank tender form will be issued to the interested parties upto 28th March 2011 which will be opened before committee on 29th March 2011 at 2.30 PM.
