







Procurement Committee evaluated/scrutinized NTN, STRN, call deposit, professional tax 2016-17, technical specification based on bid evaluation criteria and finalized the tender. In the light of justification provided by the Officer In-Charge, Livestock Experimental Station, Korangi Karachi. The Procurement Committee decided that:


- Procurement Committee allowed the purchase of all the approved items according to the availability of funds under Non-Development.
- Procurement Committee approved the lowest rates and procurement of the items from the participating bidder/companies having specification in agreement with tender specification.
- If any tax imposed by the government after the completion of tender price, then this increase in tax is allowed to be included in the quoted price of items, which were previously exempted.


