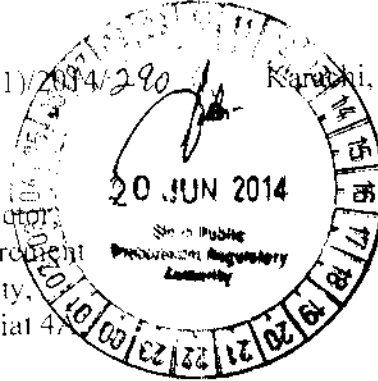



The reason was required specs were SATA Hard Drive, whereas we have quoted 500GB (7200 rpm) 2.5 inch Hybrid drive, which is SATA Hard drive, either your technical team unaware of this or your team is deliberately doing this. Kindly re-evaluate our bid and form a redressal committee to listen our grievances and concerns about your bid evaluation report.

We are rejecting your bid evaluation report and demand for Redressal as per SPPRA rule. We expect your prompt, positive and serious response in this regard.

This is in reference to your bid evaluation report of tender dated 22nd May, 2014 for procurement of Computer/Equipment & Furniture for Setting up of IT Lab, we have found the reason of our rejection was Non Responsive, Brand is not established or internationally recognized brand, first of all, we could not understand that when you have rejected us on technical grounds, then why you had opened our financial bid. Secondly our bid cannot be rejected on Brand, as SPPRA rule 13 clearly says :

13. Specifications

(1) Specifications shall allow the widest possible competition and shall not favour any single contractor or supplier nor put others at a disadvantage. Specifications shall be generic and shall not include references to brand names, model numbers, catalogue numbers or similar classifications. However, if the procuring agency is convinced that the use of a reference to a brand name or a catalogue number is essential to complete an otherwise incomplete specification, such use or reference shall be qualified with the words "or equivalent".

We were the first lowest bidder in the competition and the 2nd one was more than Rs16,000 higher than us. Kindly re evaluate our bid and form a redressal committee to listen our grievances and concerns about your bid evaluation report. We are rejecting your bid evaluation report and demand for Redressal as per SPPRA rule. We expect your prompt, positive and serious response in this regard.

MINUTES OF THE MEETING OF 'COMPLAINT REDRESSAL COMMITTEE' OF 'STEVTA' HELD ON 11.06.2014.

A meeting of the Complaint Redressal Committee, constituted vide Notification No. STEVTA/Proc/1(3)/2013/1361, dated 09.05.2014, to address the complaints lodged by M/s. Science & Computer Link, Karachi, in respect of Bid invited for procurement of 'Computers/ Hardware and I.T. Equipment for STEVTA' and procurement of 'Computers/Equipment & Furniture for setting-up of I.T. Labs: in 10 Centres of STEVTA'. Following attended the meeting:

On behalf of complainant / aggrieved bidding firm; M/s. Science & Computer Link Karachi, following representatives attended the meeting:

- 1) Mr. Abdul Rauf Khan.
- 2) Mr. Saeed Ismail.
- 3) Mr. Maqsood Junejo.

Meeting was started with the recitation from Holy Quran. The members of the Committee as well representatives of aggrieved firm introduced them with each other. Discussing the agenda of the meeting, the Director (Admn.) informed the Committee members that M/s. Science & Computer Link has submitted two complaints in response to the following two Bid Evaluation Reports, which are to be addressed separately in this meeting:

- 1) Procurement of 'Computers/Hardware & I.T. Equipment for different Wings of STEVTA'.
- 2) Procurement of 'Computers/Equipment and Furniture/Fixture for setting-up of I.T. Labs: in 10 institutes of STEVTA'.

Complaint - 1

While discussing the first letter, which was regarding procurement of Computers/Hardware & I.T. Equipment for STEVTA; the complainant firm has objected that if their bid had been rejected on technical grounds due to SATA hard drive instead of Hybrid hard drive, why the STEVTA opened their financial bid. But, the Director (Admn.) clarified that the objection of complainant firm was not valid, as the bid was single stage-one envelope. Hence, while opening the bids the rates were also opened and announced to bidders and the technical details were evaluated later with regard to specifications given in bidding document.

The representatives of complainant firm were requested to inform the Committee regarding their second objection in the Bid Evaluation Report in question. Mr. Abdul Rauf Khan, stated that they were first lowest bidder but their bid has been rejected on the grounds that they had offered SATA hard drive instead of Hybrid drive and the contract was recommended in favour of second lowest bidder at Rs.10,000/- higher than their offered rate.

The representative of firm; Mr. Saeed Ismail stated that though they had written in their quotation that they are offering SATA Hard drive, but actually 500 GB (7,200 rpm) 2.5" drive that is Hybrid drive, as in the 2.5" size only Hybrid drives are available and no SATA drive is manufactured & available in market in this size.

Dr. Muhammad Saleh Shah expressed that the physical size of a hard disk is not the criteria to assess whether it is a SATA or Hybrid drive. Hence, the firm was required to clearly mention in its quotation that they were providing Hybrid drive or simply had to agree the specifications given in the bidding document if they were giving the same specification's computer, instead of creating confusion by writing SATA hard drive. The representatives of complainant firm admitted their mistake of mentioning the SATA drive instead of Hybrid drive in their offered specifications.

After going through the contents of the specifications offered by the complainant firm, Dr. Muhammad Ali Nizamani, Assistant Professor ISRA University also clarified that neither the firm has mentioned that the drive is ~~SSD~~^{SSHD} nor the features of a Hybrid drive are mentioned by the firm in its quote. Hence, he also rejected the objection raised by the complainant firm.

With regard to rates, the Director (Admn.) clarified that the Bid in respect of article; Desktop Computer was recommended by Procurement Committee in respect of third lowest offer and not to the second lowest offer. The position of make/model and quoted rates by different firms in respect of Desktop Computer was informed to Committee, which was as follows:

He added that the above statement is evident that not only the bid of the complainant firm was rejected, but another firm's bid was rejected on the grounds of non-conformity of specifications due to offered 'SATA hard drive'. The statement also proves that one firm *M/s. Micro Innovations & Tech: Karachi* offered two products of same Brand with two prices:

- 1) Option-1 Dell Optiplex 3020MT (with *SATA Harddrive*) Rs.69,000/-
- 2) Option-2 Dell Optiplex 3020MT (with *Hybrid Harddrive*) Rs.79,800/-

Even the Brand & Models of above two offered bids were same, but there was a difference of Rs.10,800/- in both articles; just due to hard drive. Hence, the objection of complainant firm is not valid that the Procurement Committee accepted the offer of Desktop Computer, which was Rs.10,000/- higher than their quoted product.

Complaint - 2

With regard to their second complaint, Mr. Abdul Rauf Khan, the Director Operations of complainant firm stated that their bid in respect of Desktop Computer has been rejected on the grounds that our computer is not a branded computer. If they were not technically sound/ conform to the specifications, why their financial bid opened by the Committee. Besides, their bid has been rejected on the grounds that the quoted computer "One-Apple" is not a branded computer, whereas the said computer is a branded computer having its Principal's office at Canada and manufacturing in China. He further expressed that according to SPPRA rules the specifications of a required article cannot include the Brand name, whereas the STEVTA has rejected their bid on the grounds of Branded Computer.

Dr. Muhammad Saleh Shah, clarified that the STEVTA has invited bids by mentioning the Branded Computer. but the name of any Brand has not been mentioned in the Bidding Document, hence, the objection of firm regarding Brand name is not valid.

The Director (Admn) clarified that the bid regarding "Procurement of Computers/Equipment & Furniture for setting-up of I.T. Labs: in 10 VTCs of STEVTA" was a Single Stage-One Envelop Bid. Hence, while opening of Bid the rates were announced first and later the technical details were evaluated by the Committee. Therefore, the first objection of opening of financial bids was not valid.

Mr. Saeed Ismail the representative of firm expressed that they are the sole distributors of One-Apple Computers, which is a branded computer having its office in Canada. Besides, they are not only selling the desktop computers, but they are also dealing in laptops, mobile phones, mouse, key boards, LEDs with the monogram of One-Apple.

Dr. Muhammad Saleh Shah, asked the representatives of firm, whether their Brand is registered and also requested them to provide the documentary evidences regarding registration of their Brand, as just putting a label on a computer cannot be treated as an established Brand. In response, the representatives of firm showed different certificates; viz. copies of work orders of different departments mentioning the name of "One-Apple computer", appreciation certificates etc.

Dr. Muhammad Ali Nizamani expressed that the logo/monogram of "One Apple" computers is very similar to the logo/monogram of the world renowned brand of "Apple" computers, which creates confusion for the buyers too. He asked the representatives of firm to provide any document regarding registration of logo/monogram of their product, but the representatives of firm failed to produce any valid documentary evidence in support of registration of their Brand or brand logo/monogram. Dr. Muhammad Ali Nizamani clearly rejected the claim of complainant firm that One-Apple is a Branded Desktop Computer.

Dr. Baber Khan, Assistant Accountant General, the representative of A.G Sindh opined that the procedure used in said bidding was single stage one envelope and according to Rule-49 of SPPRA "The bidder with the lowest evaluated cost shall be awarded the procurement contract within the original or extended period of bid validity". He added that the aggrieved firm raised objection that they are offering "One Apple" which is an internationally recognized brand, as according to SPPRA Rule 13, the Specification shall allow the widest possible competition and shall not favour any single contractor or supplier nor put others at a disadvantage, specifications shall be generic and shall not include references to brand names, model numbers, catalogue numbers or similar classifications, however, if the procuring agency is convinced that the use of a reference to a brand name or a catalogue number is essential to complete an otherwise incomplete specification, such use or reference shall be qualified with the words or equivalent. It was a single stage bid and according to SPPRA rules the bidder offering the lowest prices has to be selected. Hence, he proposed that the Procurement Committee may reverse their decision for both the bids under discussion and award the contract to the aggrieved bidder.


After listening the view points of the representatives of complainant firm, the Committee discussed the issue in detail. Dr. Muhammad Saleh Shah and Dr. Muhammad Ali Nizamani clearly rejected the complaint of the firm whereas the representative of A.G. Sindh proposed for aggrieved bidder to give them contract.

In the light of above different opinions of members and after thread-bared discussion, Committee recommended & decided as follows:

RECOMMENDATIONS/DECISIONS:

- 1) In respect of Bid for "Procurement of Computers/Hardware & I.T. Equipment for different Wings of STEVTA", Committee rejected the appeal/complaint of M/s. Science & Computer Link, Karachi, as there was a deviation in specifications quoted by firm with the required specifications, in respect of Desktop computer.
- 2) In respect of Bid for "Procurement of Computers/Equipment & Furniture for setting-up of I.T. Labs: in Institutions of STEVTA", the Committee, on the basis of different opinions of expert members, recommended that the Bid may be cancelled and invited afresh.



On the basis of documents provided by the bidding firms in support of said requirements, all the firms were preliminary found technically qualified.

Committee also checked the specifications offered by bidding firms with regard to the specifications given in the bidding document (Detailed comparative statement of Technical Specifications is annexed at "A"). 
Committee also checked the specifications offered by bidding firms with regard to the specifications given in the bidding document (Detailed comparative statement of Technical Specifications is annexed at "A").
