





Meetings of Consultant Selection Committee were held to open and scrutinize the technical and Financial bids, in the Committee Room of Women Development Department, Govt. of Sindh, on 10<sup>th</sup> February, 2017 & 27<sup>th</sup> February, 2017 respectively, & to finalize offer called in response to press advertisement appeared in leading newspapers as RFP for Selection of Consultant for "Training for Legal Empowerment of Women" and "Training for Economic Empowerment of Women" on 26-02-2017, under ADP Scheme "Advocacy for Women Empowerment in Sindh".

2. On 10-02-2017 meeting of "Consultant Selection Committee" was held to open technical bid as per terms and Conditions, Bidders were supposed to drop their offer in two separate envelopes marked as "technical bid" and Financial bid". Eleven bids were received for competition out of which two bidders i.e. Ms. Indus Crafts & Ms. BSWA were disqualified for dropping both bids in single envelope.

3. On examination under qualifying criteria Ms. SMIU hadn't enclosed required documents while Ms. SPARC hadn't attached the required documents, hence not qualified to compete.

4. Remaining bids were scrutinized on the basis of "Technical Evaluation Criteria". Minimum qualifying marks required for technical qualification is 70%. M/S PEHL has failed to meet criteria, hence disqualified.

5. The Financial bids of technically successful bidders were opened and scrutinized by the same Committee on 27<sup>th</sup> February, 2017.

6. The Technical Evaluation Form (Annex. A), Comparative Statements of financial proposal (Annex.B) and Bid Evaluation report (Annex. C), for selection of Consultant are attached.
