As authorized by the Government of Sindh, under section 4 of the Sindh Building Control Ordinance, 1979, (as amended up to date) vide Notification No SO(L&C)/HTP/1-8/2008 Dated 10th July, 2013 (herein referred to as the Client) of the first part;

And

National Engineering Services Pakistan (Pvt) Limited, Architecture & Planning Division Karachi 4th Floor, N.I.C.L Building, Abbasi Shaheed Road, Off Shahrah-e-Faisal, Karachi, through its Authorization issued by MD. NESPAK dated 22-10-2013, representative named Muhammad Arif Changazi, General Manager/Head Architecture & Planning Division Karachi, 4th Floor, N.I.C.L Building, Abbasi Shaheed Road, Off Shahrah-e-Faisal, Karachi (here in referred to as Consultant), of the second part.

SPECIAL ADHESIVE

WHEREAS THE first part/Client which is an Public Authority namely Sindh Building Control Authority, which has been established by the Government of Sindh under Sindh Building Control Ordinance, 1979, the first part/client is desirous of getting built its own 'Head Office Building', at Karachi strictly in accordance with the law of the land and approved building plan as approved by the concerned authority for the said purpose the authority has invited professional Consultancy for the said purpose.

AND WEREAS The second part or the said Consultants namely M/S National Engineering Services Pakistan (Pvt) Limited (NESPAK) are Pakistan's premier consultancy organization. Its international stature is well established and it enjoys the reputation of being one of the top engineering consultancy organizations in Asia and Africa and is ranked amongst the world's top 200 consulting firms has offered to build the said building according to the law of the land and specifically as per approved building plan on the following terms and conditions.

NOW, THERE FORE, THIS AGREEMENT WITNESS as follows:

1. ARTICLE 1: THE PROJECT

The Project for which Services are required to be performed under this Agreement is described in the attached Appendix 'A'.

2. ARTICLE 2: SCOPE OF SERVICES

The scope of consultancy and other professional services (herein referred to as "Services") as per RFP (TOR) to be performed by the Consultant for the Project under this Agreement are described in the **Appendix A**.

3. ARTICLE 3: TIME SCHEDULE

3.1 Effective Date of Commencement

Effective Date of Commencement of services shall be as defined in the attach Appendix B.

3.2 Time Schedule of Services;

The time schedule of services is given in the attached **Appendix B.**

3.3 Extension of Time;

Extension of Time for completion of the said professional Services (the details of the said TOR is attached herewith in Technical and Financial proposal submitted by Consultant which may kindly be treated as part and parcel of this Agreement) and the terms and conditions thereof shall be mutually agreed between the Client or first part and the second part or Consultant as and when required **Appendix B**.

4. ARTICLE 4: MODE OF OPERATION

4.1 Obligation of the (second part or Consultant);

- (A) The second part or Consultant shall perform the said services as an independent consultant in accordance with recognized international standards, applicable land laws and regulations.
- (B) The second part or Consultant shall appoint a Project Manager named in Appendix D who shall represent the Consultant for purpose of this Agreement and shall be responsible for the execution & administration of this Agreement including performance of Services there under. He shall remain in contact with the representative of Client whom fully informed in respect of all matters relating to the provision of said Services of the Consultant.
- (C) The second part or Consultant shall carry out the Services with due diligence and efficiency and in conformity with sound engineering practices.

- (D) The second part or Consultant shall act at all times so as to protect the interests of the Client and shall take all reasonable steps to keep all expense to a minimum consistent with sound economic and engineering practices.
- (E) The second part or Consultant shall furnish the Client such information relating to the Services as the Client may from time to time reasonably request.
- (F) Except with the prior written approval from the Client, the second part or Consultant shall not assign or transfer the said agreement or Professional Services or any part thereof nor engage any other independent Consultant or sub-consultant to perform any part of the said Services for the said project.
- (G) The second part or Consultant agrees that no proprietary and confidential information received by the Consultant from the Client shall be disclosed during the term of this Contract and within Two year after its expiration to a third party unless the Consultant receives a written permission from the Client to do so.

4.2 Obligations of the Client or first part;

The Client or first part shall provide to the second part or Consultant:

- (A) All necessary data/ document/ reports that may be required by the second part or Consultant for performing the Services within the Time Schedule given in **Appendix B.**
- (B) The Client shall designate a person named in **Appendix D** to act as its representative on all matters pertaining to this agreement and to fully cooperate with the Project Manager of the Consultant
- (C) The Client shall take all necessary measures to make timely payments to the Consultant as stipulated in Article 5 (Appendix-C), Consultant.

5. ARTICLE 5: REMUNERATION FOR SERVICES AND SCHEDULE OF PAYMENT.

The remuneration for services rendered by the second part or Consultant and the mode of payment shall be as described in the attached **Appendix -C**. During project period, No inflation has been allowed to second part or Consultant.

6. ARTICLE 6: ECONOMIC PRICE ADJUSTMENT

In order to adjust the remuneration for inflation, a price adjustment provision has been included if the contract has duration of more than 18 months. The adjustment will be made every 12 months after the date of the contract for remuneration. Remuneration will be adjusted by using the relevant index as per following provision.

"Payments for remuneration made in accordance with Article – 5 shall be adjusted as follows:

Remuneration pursuant to the rates set forth in Annex- C shall be adjusted every 12 months (and, for the first time, with effect for the remuneration earned in the [13] the calendar month after the date of the Contract) by applying the following formula:

$R_1 = R_{10} \times I_1 / I_{10}$

Where $R_{l\,is}$ the adjustment remuneration, R_{l0} is the remuneration payable on the basis of the rates set forth in Annex C for payable remuneration, I_l is the official rate of inflation for the first month for which the adjustment is to have effect and, I_{l0} is the official rate of inflation for the month of the date of the Contract."]

7. ARTICLE 7: ADDITIONAL SERVICES

The Client may ask the second part or Consultant to perform additional Services during the currency of this Agreement such Additional Services shall be performed with the prior concurrence of both the parties. The Consultant shall submit an estimate of the additional time (if any) and the, additional remuneration for such additional Services which shall be approved in writing by the Client before the commencement of the additional Services.

8. ARTICLE 8: TERMINATION

8.1 End of Services

This Agreement has been terminated subject to the condition that when the second part or Consultant shall submit their specific certificate in respect of completion of the said SBCA Head Office Building that the said building has been completed satisfactorily, strictly in accordance with the specification, approved building plan and the concern authority will issue a completion certificate, in accordance with law.

8.2 Termination by the Client

The Client may, by a written notice of thirty (30) days to the second part or Consultant, terminate this agreement. All accounts between the Client and the second part or Consultant shall be settled not later sixty (60) days of remunerations have been made.

8.3 Termination by the second part or Consultant

The second part or Consultant may suspend the Agreement by a written notice of Three months only if the second part or Consultant does not receive payments due under this Agreement within ninety (90) days of submission of its invoice. If the payment is still not made to the second part or Consultant after Three months written notice of suspension, the second part or Consultant may terminate this Agreement in whole or in part by giving sixty (60) days advance notice of intent to terminate. If the Agreement is terminated by the second part or Consultant under such circumstances, the Client shall pay, within a period of thirty (30) days of the date of such notice of intent to terminate referred, above, all payments due to the Consultant.

9. ARTICLE 9: FORCE MAJEURE

- (A) The term "Force Majeure" as employed herein shall mean acts of God, strikes, lock-out or other industrial disturbance, acts of public enemy, wars, blockades, insurrection, riots, epidemics, landslides, earthquakes, storms, lightning, floods, washouts, civil disturbances, explosions and any other similar events, not within the control of either party and which by the exercise of due diligence neither party is able to overcome.
- (B) If either party is temporarily unable by reason of force Majeure or the laws or regulations of Pakistan to meet any of its obligations under the Agreement, and
- (C) if such party gives to the other Party written notices, of the event within fifteen (15) days after its occurrence, such obligations of the party, as it is unable to perform by reason of the event, shall be suspended for as long as the inability Continues. Neither party shall be liable to the other party for loss or damage sustained by such other party arising from any event referred to as Force Majeure or delays arising from such event. Force Majeure shall not include insufficiency of funds or failure to make any payment required under the Agreement.

10. ARTICLE 10: RESOLUTION OF DISPUTES

Any dispute or difference arising out of the Agreement which cannot be amicably settled between the parties, shall be finally settled under the provisions of the Arbitration Act, 1940(Act no. 1940) and Rules made there under as amended from time to time. The venue of arbitration shall be in Pakistan as given in **Appendix D**, Special condition.

11. ARTICLE 11: APPLICABLE LAWS

This Agreement shall, in all respects, be read and constructed shall operate in conformity with the laws of Pakistan and the courts at the location indicated in **Appendix D**, Special Conditions shall have exclusive jurisdiction for adjudicating and interpreting the Agreement.

12. ARTICLE 12: CONTRACT AMENDMENT

No variation or changes to the terms of the Agreement shall be made, except by a written amendment signed by parties hereto.

13. ARTICLE 13: OWNERSHIP OF MATERIAL

Any studies, reports or other material, graphic, software or otherwise, prepared by the second part or Consultant for the Client under the Contract shall belong to and remain the property of the Client. The second part or Consultant may retain a copy of such documents and software.

ARTICLE 14: INSURANCE 14.

The second part or Consultant shall be responsible for comprehensive insurance coverage to his all employees, labours, sub-contractors, for their personnel and other equipment's etc regarding the said project. The said insurance shall remain intact till its completion.

ARTICLE 15: NOTICES 15.

Any notice given by any of the Parties shall be sufficient only if in writing and delivered in person or through registered mail as follows:

C-2 SCHEDULE OF PAYMENTS:-

Based on space requirement provided in TOR, the preliminary conceptual design of SBCA Head Office Building will be around 250,000 sq.ft with prevailing construction markets rates at Rs.2800/- per sq.ft (including Labours & material) therefore the **Tentative Estimated Construction Cost of the Project is estimated as Rs. 700 million by SBCA.** The estimated remuneration for Design Services being 1.75% is Rs. 12.25 Million which will be paid as under:

ii) STAGE-II: - CONSTRUCTION SUPERVISION

- a). The Consultancy fee during construction stage shall be paid in equal monthly installments payable during stipulated period of Construction/ as defined in the construction contract.
- b). For any extension in Supervision Period, the consultants shall be paid monthly installments on the rates for original monthly installment which will be adjusted from final adjustment of remuneration to consultant.
- c). The final bill of the consultants shall be established on completion of works / establishment of Final Contract Price of Construction Contract(s).
- d). 10% security deposit shall be withheld from each payment to consultant which shall be refunded after expiry of maintenance period of Building by the Contractor. The maintenance period shall be one year after completion certificate issued by client to contractor duly verified by consultant.

- 2. Second Interim adjustment shall be done on the basis of Cost of Project awarded to Contractor and accordingly Design Fee & Construction Supervision Fee shall be adjusted/paid to Consultant i.e NESPAK as mutually agreed.
